EASEMENT

KNOW ALL MEN BY THESE PRESENTS that Cole Investment Company, a Nebraska corporation, hereinafter referred to as "Grantor", for One Dollar (\$1.00) and other valuable consideration, does hereby grant unto Burlington Northern, Inc., a corporation, hereinafter referred to as "Grantee", the right, license, privilege and easement to enter upon and use for railroad purposes, and to construct, maintain, operate, repair, renew and remove standard gauge railroad trackage on, over and across the premises described as follows, to wit:

PARCEL #1: A strip of land in Lot 4, Block 1, Cole Industrial Park, described as the West 25' of the North 242.34' of said Lot 4 and a strip of land 50' in width centered on a line which runs from the Southeast corner of said Lot 2, Block 1, to a point 30.02' East of the Southwest corner of said Lot 4.

PARCEL #2: A strip of land in Lot 3, Block 1, Cole Industrial Park, 25' in depth, adjacent to and normal to the West line of said Lot 3 located in the SW 1/4 of Section 33, TllN, R7E of the 6th P.M., Lancaster County, Nebraska.

PARCEL #3: A strip of land in Lot 2, Block 1, Cole Industrial Park, 25' in depth, adjacent to and normal to the East property line of said Lot 2, located in the SW 1/4 of Section 33, TllN, R7E of the 6th P.M., Lancaster County, Nebraska.

PARCEL #4: A strip of land in Lot 1, Block 2, Cole Industrial Park, 25' in depth, adjacent to and normal to the Southeast property line of said Lot 1, located in the SW 1/4 of Section 33, TllN, R7E of the 6th P.M., Lancaster County, Nebraska.

PARCEL #5: A strip of land in Lot 2, Block 2, Cole Industrial Park, 25' in depth, adjacent to and normal to the Northwest property line of said Lot 2, located in the SW 1/4 of Section 33, T11N, R7E of the 6th P.M., Lancaster County, Nebraska.

Reserving, however, unto to said Grantor, its successors, assigns and licensees, the right to operate, maintain and renew such vehicular crossings, pipe lines, electric transmission lines, water lines, sewer lines and other facilities of like character as may exist upon, under or over said premises as of the date hereof, and from time to time construct, operate, maintain and renew such additional facilities of the same character, or relocate existing facilities, in such manner as will not interfere with the use of the premises by the Grantee for the purposes herein specified.

To have and to hold the said right, license, privilege and easement unto the Grantee, its successors and assigns forever, subject, however, to the condition that if at any time hereafter the railroad trackage on the premises described above, or any part thereof, shall cease being used and shall be removed by the Grantee, its successors or assigns, then the said right, license, privilege and casement herein granted shall cease to determine and immediately thereupon revert and revest in the Grantor, its successors and assigns, without any further or other conveyances from Grantee or its successors or assigns.
