LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement ("2012 Modification Agreement") is entered into by and between EAST CAMPUS REALTY, LLC, a Nebraska limited liability company ("Borrower") and MUTUAL OF OMAHA INSURANCE COMPANY, a Nebraska mutual insurance company, its successors and assigns ("Lender") effective November 29, 2012.

Recitals

- A. Borrower executed and delivered to Lender a certain Promissory Note dated December 1, 2010 in the original principal amount of \$273,400,000.00 (the "Note").
- B. As collateral for the Note, Borrower executed and delivered to Mutual of Omaha Bank, as trustee, for the benefit of Lender, as beneficiary, a certain Deed of Trust, Security Agreement, Assignment of Leases and Rents and Financing Statement dated December 1, 2010 (the "Deed of Trust"), which was recorded in the office of the Register of Deeds of Douglas County, Nebraska on December 3, 2010 as Instrument No. 2010115066.
- C. As additional collateral for the Note, Borrower executed and delivered to Lender a UCC Financing Statement (the "Financing Statement"), which was recorded in the Nebraska Secretary of State's office on December 6, 2010 as Document Number 9910644707-4.
- D. Borrower and Lender entered into a Loan Modification Agreement ("2011 Modification Agreement") effective November 30, 2011 whereby certain provisions of the Note and Deed of Trust were amended, including but not limited to, extending the original maturity date of the Note from December 1, 2011 to November 30, 2012. The 2011 Modification Agreement was recorded in the office of the Register of Deeds of Douglas County, Nebraska on November 29, 2011 as Document No. 2011101857.
- E. Borrower and Lender desire to make further amendments to certain terms and provisions of the Note and Deed of Trust.

NOW THEREFORE, for good and valuable consideration, Borrower and Lender hereby agree as follows:

1. <u>Note</u>. Terms capitalized in this paragraph 1 and not otherwise defined shall have the meanings ascribed to them in the Note. Borrower and Lender hereby amend the Note as follows:

The maturity date of "November 30, 2012" appearing in Section (b) of the first paragraph is deleted and "November 29, 2013" is substituted as the maturity date.

- 2. <u>Deed of Trust</u>. Terms capitalized in this paragraph 3 and not otherwise defined shall have the meanings ascribed to them in the Deed of Trust. Borrower and Lender hereby amend the Deed of Trust as follows:
 - (a) The maturity date of "November 30, 2012" in Paragraph 1.1 is deleted and "November 29, 2013" is substituted as the maturity date.
 - (b) Exhibit A is deleted and the Exhibit "A" attached to this 2012 Modification Agreement is substituted.
- 3. <u>Ratification</u>. Except as amended by this 2012 Modification Agreement or the 2011 Modification Agreement, all of the original terms and provisions of the Note, Deed of Trust and all other Loan Documents shall continue in full force and effect and the Note, Deed of Trust and all other Loan Documents, as amended by this 2012 Modification Agreement, are hereby ratified and confirmed.
