## FIRST AMENDMENT TO COMMON AREA MAINTENANCE AGREEMENT

THIS FIRST AMENDMENT TO COMMON AREA MAINTENANCE AGREEMENT (this "First Amendment") is made this 5 day of \_\_\_\_\_\_, 2013 (the "Effective Date"), by and among PETERSON CHANDLER SHAMROCK, LLC, a Nebraska limited liability company (hereinafter referred to as "Peterson Chandler Shamrock"), PETERSON PARCEL, LLC, a Nebraska limited liability company (hereinafter referred to as "Peterson"), and PPP LOT 4, LLC, a Nebraska limited liability company (hereinafter referred to as "PPP"; Peterson Chandler Shamrock, Peterson and PPP shall be collectively referred to herein as the "Parties").

## **RECITALS:**

WHEREAS, Peterson Chandler Shamrock, LLC is the owner of the real property legally described as Lot 1, Papillion Professional Park Replat One, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska (the "Peterson Chandler Shamrock Property"), which property was formerly legally described as Lot 1 and Lot 2, each in Papillion Professional Park, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska, and was combined into one (1) lot pursuant to a replatting (the "Lot Combination").

WHEREAS, Peterson is the owner of the real property legally described as Lot 3, Papillion Professional Park, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska (the "Peterson Property").

WHEREAS, PPP is the owner of the real property legally described as Lot 4, Papillion Professional Park, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska (the "PPP Property").

WHEREAS, the Parties are parties to that certain Common Area Maintenance Agreement recorded July 2, 2002 as Instrument No. 200224669 with the Sarpy County, Nebraska Register of Deeds (the "Maintenance Agreement"), which Maintenance Agreement sets forth the Parties' agreements relating to the maintenance of the Parcels.

- 3. <u>Amendment to Section 7.1</u>. The table appearing at the end of the last sentence of Section 7.1 of the Maintenance Agreement is hereby deleted in its entirety and replaced with the following:

Parcel 1: 50% Parcel 3: 25% Parcel 4: 25%

- 4. <u>Amendment to Schedule I</u>. Schedule I to the Maintenance Agreement is deleted in its entirety and replaced with the Schedule I attached hereto.
- 5. <u>No Other Amendment</u>. Except as specifically set forth herein, the Maintenance Agreement shall remain in full force and effect.
- 6. <u>Counterparts</u>. This First Amendment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original and all of which, when taken together, constitute one and the same document. The signature of any party to any counterpart shall be deemed a signature to, and may be appended to, any other counterpart.
