

EXHIBIT "A"

A tract of land consisting of part of Lots 14, 15, 16 and 25 and all of Lots 23 and 24, and the vacated alley abutting said Lots, all in Block 4, Briggs Place Addition, an addition located in the NW 1/4 of Section 20, Township 15 North, Range 13 East of the 6th P.M., in the City of Omaha, Douglas County, Nebraska, more particularly described as follows:

Beginning at the Southwest corner of said Lot 23, Block 4, Briggs Place Addition; thence N 00°00'00" E (assumed bearing) along the East right-of-way line of the Omaha Beltline Railway, a distance of 220.00 feet; thence S 89°16'00" E, a distance of 152.20; thence S 00°00'00" E, a distance of 220.00 feet to a point on the Northerly right-of-way line of Dodge Street; thence N 89°16'00" W, along said Northerly right-of-way line of Dodge Street, a distance of 152.20 feet to the point of beginning.
