Ordinance No. 83.

An Ordinance Amending Section 1 of Ordinance No. 81 of the City of Emmetsburg, Iowa, Relating to the Establishment of Restricted Residence Districts.

Be it Ordained by the Council of the City of Emmetsburg, Iowa: That Section 1 of Ordinance No. 81 of the City of Emmetsburg, Iowa, be and the same is hereby amended by adding thereto the following:

SECTION 1-a. \* \* \*All that part of Blocks 15 and 16 of Burnham's Addition lying east of the C.R.I. & P. Ry. Co. right-of-way, also describes other real property not covered by this abstract) all of said property being located in the City of Emmetsburg, Iowa.

SECTION 1-b. That said Section 1 of Ordinance No. 81, of said City, as herein amended, be and the same is as follows, to-wit:

Districts. There is hereby designated and established, within the said City, the following restricted residence district:

\* \* \*That Part of Blocks 15 and 16 of Burnham's Addition lying east of the C.R.I. & P. Ry. Co., right-of-way, (also describes other real property not covered by this abstract), all of said property being located in the City of Emmetsburg, Iowa.

SECTION 1-c. Certifying Ordinances. Immediately and within five days after this ordinance becomes in effect, the clerk shall prepare, or cause to be prepared, a plat of the restricted residence districts as established by this ordinance, and certify such ordinance and plat to the county recorder. (5724 to 5727)

SECTION 1-d. This ordinance shall be in force and effect from and after its passage and publication as provided by law.
