SECTION 1. Ordinance 81 of the City of Emmetsburg, Iowa as amended by order No. 114 is hereby amended by repealing Section 1 of said Ordinance No. 81 and substituting therefor the following:

Section 1. Districts. There is hereby designated and established within the said City the following restricted residence district:
