Legal Description 1:

Part of the SW ¼ Section 2, Township 16 North, Range 9 East of the 6th P.M., Douglas County, Nebraska, described as follows: beginning at the Northwest corner of said Southwest ¼; thence South 02 degrees, 07 minutes, 33 seconds West (assumed bearing) for 798.08 feet along the West line of said Southwest ¼; Thence South 88 degrees 00 minutes, 12 seconds East for 571.32 feet parallel with and 798.08 feet South of the North line of said Southwest ¼; Thence North 00 degrees, 14 minutes, 54 seconds West for 501.52 feet; thence 88 degrees, 00 minutes, 12 seconds, East for 1147.00 feet parallel with and 296.94 feet South of the North line of said Southwest ¼; Thence North 02 degrees, 01 minutes, 33 seconds East for 296.94 feet to the North line of said Southwest ¼; thence North 88 degrees, 00 minutes, 12 seconds, West for 1697.02 feet to the point of beginning.
