THERE WILL BE NO INGRESS OR EGRESS OVER THE FOLLOWING DESCRIBED CONTROLLED ACCESS LINE LOCATED IN THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER, KNOWN AS SUBLOT 2 OF LOT 15 OF SECTION 15, TOWNSHIP 12 NORTH, RANGE 9 EAST OF THE SIXTH PRINCIPAL MERIDIAN, CASS COUNTY, NEBRASKA:

REFERRING TO THE NORTHEAST CORNER OF SAID QUARTER QUARTER SECTION; THENCE WESTERLY A DISTANCE OF 40.20 FEET ALONG THE NORTH LINE OF SAID QUARTER QUARTER SECTION; THENCE SOUTHERLY ON A 584.70 FOOT RADIUS CURVE TO THE RIGHT, DEFLECTION TO THE INITIAL TANGENT BEING 076 DEGREES, 14 MINUTES, 23 SECONDS LEFT, A DISTANCE OF 77.57 FEET, SUBTENDING A CENTRAL ANGLE OF 007 DEGREES, 36 MINUTES 03 SECONDS ALONG THE NORTHERLY EXISTING HIGHWAY 6 RIGHT OF WAY LINE TO THE POINT OF BEGINNING; THENCE SOUTHERLY ON A 584.70 FOOT RADIUS CURVE TO THE RIGHT, DEFLECTION TO THE INITIAL TANGENT BEING 000 DEGREES, 00 MINUTES, 00 SECONDS A DISTANCE OF 163.36 FEET, SUBTENDING A CENTRAL ANGLE OF 016 DEGREES, 00 MINUTES 28 SECONDS ALONG SAID RIGHT OF WAY LINE; THENCE SOUTHWESTERLY DEFLECTING 014 DEGREES, 15 MINUTES, 36 SECONDS RIGHT, A DISTANCE OF 354.60 FEET ALONG SAID RIGHT OF WAY LINE; THENCE SOUTHWESTERLY ON A 2904.79 FOOT RADIUS CURVE TO THE LEFT, DEFLECTION TO THE INITIAL TANGENT BEING 000 DEGREES, 00 MINUTES, 00 SECONDS A DISTANCE OF 728.50 FEET, SUBTENDING A CENTRAL ANGLE OF 014 DEGREES, 22 MINUTES 10 SECONDS ALONG SAID RIGHT OF WAY LINE; TO THE POINT OF TERMINATION; EXCEPT, OVER ONE UNRESTRICTED DRIVE(S) NOT TO EXCEED 40 FEET IN WIDTH, THE CENTERLINE(S) OF WHICH (IS, ARE) LOCATED SOUTHWESTERLY 335.43 FEET FROM THE EAST LINE OF QUARTER QUARTER SECTION AS MEASURED ALONG THE HIGHWAY CENTERLINE.
