WHEREAS, Beggs-Riffel-Wyant partnership was the owner of the property described in Exhibit "A" and transfer the same to Sarpy County, pursuant to the IDA bond issue and is now a Lessee of the property pursuant to a lease between itself and Sarpy County; and,

WHEREAS, the District is desirous of constructing a sanitary sewer line across the property described in Exhibit "A" and it is necessary to obtain a construction easement for the construction phase of the project and a permanent easement for the sewer line after the construction of the project.




