WARRANTY DEED

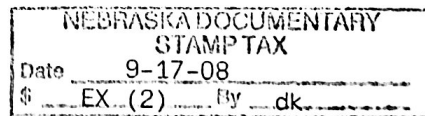

Referring to the NW corner of the NW1/4 of NW1/4 of Sec. 23-T7N-R3E; thence east, along the north section line of the NW1/4 of NW1/4 of Sec. 23-T7N-R3E, a distance of 400.00 feet to the point of beginning; thence continuing east, along the north section line of the NW1/4 of NW1/4 of Sec. 23-T7N-R3E, a distance of 931.07 feet; thence south, perpendicular, a distance of 60.00 feet; thence west, perpendicular, a distance of 631.07 feet; thence north, perpendicular, a distance of 15.00 feet; thence west, perpendicular, a distance of 300.00 feet; thence north, perpendicular, a distance of 45.00 feet to the point of beginning containing 1.18 acres, more or less, of which 0.71 acres, more or less, is already public right-of-way, the remaining 0.47 acres, more or less, being the land hereby acquired.

- (3) warrants and will defend title to the real estate against the lawful claims of all persons.

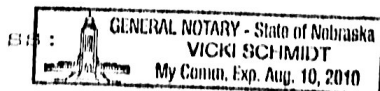
