ORDINANCE NO. 126

AN ORDINANCE VACATING THAT PORTION OF "H" STREET FROM THE WESTERLY LINE OF 6TH STREET TO THE EASTERLY LINE OF THE ALLEY ABUTTING THE WESTERLY LINES OF BLOCKS 35 AND 36, TOWN OF MILLARD AS SURVEYED, PLATTED AND RECORDED.

WHEREAS, a Petition by all of the resident owners of the property abutting upon that portion of "H" Street from the westerly line of 6th Street to the easterly line of the alley abutting the westerly lines of Blocks 35 and 36, Town of Millard as surveyed, platted and recorded, has heretofore been filed with the Village Clerk of the Village of Millard, Nebraska; and

WHEREAS, the said property owners have in and by said Petition waived any and all damages that may be occasioned by the vacating of the said Street above described.

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF MILLARD, NEBRASKA:

Section 1. That the portion of "H" street from the westerly line of 6th Street to the easterly line of the alley abutting the westerly lines of Blocks 35 and 36, Town of Millard, as surveyed, platted and recorded, be, and the same hereby is, vacated.

Section 2. This Ordinance shall take effect after passage, approval and publication as required by law.

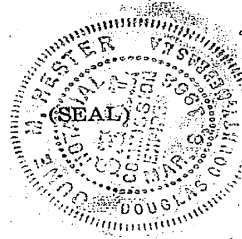
