Pursuant to a written stipulation heretofore entered into by and between the parties the court does hereby order, adjudge and decree as follows:

- 1. Judgment is entered for the plaintiff and against the defendant in the total amount of One Hundred Seventy-Eight Thousand Seven Hundred Eleven and no/100 Dollars (\$178,711.00); that said sum shall constitute full settlement for any and all compensation of every kind and nature due and owing the plaintiff by reason of the condemnation proceeding brought by the defendant and against the plaintiff before the County Judge of Sarpy County, Nebraska.
- 2. That the appropriation described in the condemnation proceeding filed before the County Judge of Sarpy County, Nebraska, is hereby affirmed, other than as modified by this decree.
- 3. That a copy of the attached description and plat be filed with the County Judge of Sarpy County, Nebraska, and replace the description and plat presently filed with the Petition and Return of Appraisers filed before the County Judge of Sarpy County, Nebraska.

B

- 4. That the description and plat for Tract 45 attached to the Return of Appraisers filed with the Register of Deeds for Sarpy County, Nebraska, under Instrument No. 2010-03923, Pages I, J, K, are hereby superseded and replaced by the description and plat attached hereto, marked Exhibit A and Exhibit B respectively, and made a part hereof by this reference.
- 5. That Defendant has no objection to a full movement three lane access point for the Lot 95 shown on Exhibit B providing northbound and southbound access to and from 168th Street so long as such access point is installed outside of the "New Controlled Access" area depicted on Exhibit B.
- 6. That each party shall bear all of its own costs and expenses herein except that the cost of certifying a copy of this Order to the County Judge of Sarpy County, Nebraska, and to the Register of Deeds of Sarpy County, Nebraska, be taxed to the defendant.
- 7. That a copy of this Order be certified by the Clerk of the District Court of Sarpy County, Nebraska, to the Register of Deeds of Sarpy County, Nebraska, and said Register of Deeds is hereby directed to record the same. The Register of Deeds is further directed, after recording the Order and attached description and plat, to return them to the State of Nebraska, Department of Roads, Legal Office, P.O. Box 94759, Lincoln, NE 68509-4759.
- 8. That a copy of this Order be certified by the Clerk of the District Court of Sarpy County, Nebraska, to the County Judge of Sarpy County, Nebraska; that said County Judge is hereby authorized

and directed to make payment to the plaintiff in the sum of Seventeen Thousand Eight Hundred Twenty-One and no/100 Dollars (\$17,821.00) for the reason that the plaintiff has previously withdrawn One Hundred Sixty Thousand Eight Hundred Ninety and no/100 Dollars (\$160,890.00) by stipulation of the parties hereto from the funds deposited with the County Judge by the defendant, and to return the balance of said funds plus interest, if any, to the defendant.

8. That upon performance of said acts the County Judge of Sarpy County, Nebraska, is hereby directed to notify the Clerk of the District Court of Sarpy County, Nebraska, that disbursement of the funds has been made according to the terms of this Order of court and such notification of the payment of the sum of One Hundred Seventy-Eight Thousand Seven Hundred Eleven and no/100 Dollars (\$178,711.00) shall be entered by the Clerk of the District Court of Sarpy County, Nebraska, as satisfaction of the judgment.




