FIRST AMENDMENT TO GROUND LEASE

This First Amendment to Ground Lease is made and entered into as of the day of May, 1999, by and between TRINITY EVANGELICAL LUTHERAN CHURCH, a Nebraska nonprofit corporation (the "Landlord") and IMMANUEL RETIREMENT COMMUNITIES, a Nebraska nonprofit corporation (the "Tenant").

WHEREAS, Landlord and Tenant entered into that certain Ground Lease dated December 16, 1998, (the "Lease") providing for the leasing of certain real property to Tenant and all as more particularly referred to and delineated in the Lease; and

WHEREAS, the Leased Premises as described on Exhibit "C" to the Lease contains an incomplete legal description and accordingly needs to be replaced with a new legal description for the Leased Premises accurately describing the Leased Premises; and

WHEREAS, the Common Areas as depicted on Exhibit "D" to the Lease were not appropriately delineated and legally described and accordingly a new Exhibit "D" has now been prepared which accurately delineates and legally describes the Common Areas referenced in the Lease and should be substituted for the existing Exhibit "D" to the Lease; and

WHEREAS, Landlord and Tenant are agreeable to amending the Lease to make the foregoing described revisions to the Lease.

NOW, THEREFORE, in consideration of the terms, covenants, conditions and agreements as hereinafter set forth Landlord and Tenant hereby agree as follows:

- 1. <u>Exhibit "C" Leased Premises</u>: The Lease is hereby amended by deleting the existing <u>Exhibit "C"</u>, <u>Legal Description of Leased Premises</u> attached to the Lease and inserting in lieu thereof the attached <u>Exhibit "C"</u>, <u>Legal Description of Leased Premises</u>. All references in the Lease to the Leased Premises shall mean and refer to the Leased Premises legally described on the Exhibit "C" attached hereto.
- 2. <u>Exhibit "D" Common Areas</u>: The Lease is hereby amended by deleting therefrom the existing <u>Exhibit "D"</u>, <u>Site Plan of Development Site Showing Common Areas</u> attached to the Lease and inserting in lieu thereof the attached <u>Exhibit "D"</u>, <u>Site Plan of Development Site Showing Common Areas</u>. All references in the Lease to the Common Areas shall mean and refer to the Common Areas delineated and legally described on the Exhibit "D" attached hereto.
- 3. **No Other Modifications:** Except as otherwise specifically amended herein, all of the terms, covenants, conditions and agreements of the Lease shall remain unmodified and continue in full force and effect.


