Now on this 7<sup>th</sup> day of March, 2017, this matter comes before the Court upon the Complaint previously filed herein. The State of Nebraska, Plaintiff, is represented by Stephen J Kraviec, Authorized Attorney. Defendant, Kevin John Eggerling was not present. Third Party Defendant, Shaena Patrish Eggerling was not present. Default taken and entered.

Evidence offered, cause submitted.

The Court, being fully advised in the premises, finds as follows:

- That the Court has jurisdiction of the parties and the subject matter of this action.
- 2. That Shaena Patrish Eggerling is the mother of the following minor dependent children:

Kannen Michael Lee Eggerling, born September, 2008, his SSN is XXX-XX-9975 Dannie Heye Eggerling, born February, 2010 whose SSN is XXX-XX-1418 Creedence Jacob Eggerling, born June, 2012 whose SSN is XXX-XX-1713

- That Defendant is the father of said children.
- 4. That the parties reside together therefore no child support shall be ordered.
- 5. That Defendant and/or Third Party Defendant shall provide health and medical insurance coverage for said minor dependent child, which is or may become available to either party at a reasonable cost through an employer, organization or other group. Once health insurance is obtained, the party obtaining health insurance shall immediately advise the other party in writing, in advance, if possible, in the event any such insurance becomes unavailable. The party obtaining health insurance shall also communicate with the other party concerning coverage and policy number(s) and shall assist in filing any medical claims when requested. Either party may satisfy this obligation to provide health insurance by including the minor child herein under their spouse's health insurance plan.
- 6. The custodial parent shall pay the first four hundred and eighty dollars (\$480.00) per child per year of all unreimbursed medical expenses or the amount as otherwise revised by the Nebraska Supreme Court Guidelines; the balance of unreimbursed medical expenses shall be paid fifty percent (50%) by each party. The party providing health insurance shall at least every six (6) months supply to the other party, an accounting of unreimbursed medical expenses and the other party shall pay their portion thereof within (30) days of receipt of the itemization. Unreimbursed medical expenses may include, but are not limited to medical treatment, dental, orthodontic and vision expenses.

- 7. At the present time, health insurance is not available at a reasonable cost and/or is not accessible; therefore Defendant is hereby ordered to pay cash medical support in the amount of \$115.00 per month, beginning March 1, 2017 and continuing on the first day of each month thereafter until the minor child reaches the age of majority, marries, dies or until further order of the Court.
- 8. In the event cash medical support is ordered and the responsible party obtains Health Insurance for the minor child, upon notice by the County Attorney, Authorized Attorney or Nebraska Department of Health and Human Services the Clerk of the District Court shall suspend further accrual of the cash medical support order until notified otherwise

#### IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT:

1. Defendant is the father of the following named children:

Kannen Michael Lee Eggerling, born September, 2008 Dannie Heye Eggerling, born February, 2010 Creedence Jacob Eggerling, born June, 2012

- 2. The parties reside together therefore no order of child support is ordered.
- 3. That Defendant and/or Third Party Defendant shall provide health and medical insurance coverage for said minor dependent child, which is or may become available to either party at a reasonable cost through an employer, organization or other group. Once health insurance is obtained, the party obtaining health insurance shall immediately advise the other party in writing, in advance, if possible, in the event any such insurance becomes unavailable. The party obtaining health insurance shall also communicate with the other party concerning coverage and policy number(s) and shall assist in filing any medical claims when requested. Either party may satisfy

- this obligation to provide health insurance by including the minor child herein under their spouse's health insurance plan.
- 4. The custodial parent shall pay the first four hundred and eighty dollars (\$480.00) per child per year of all unreimbursed medical expenses or the amount as otherwise revised by the Nebraska Supreme Court Guidelines; the balance of unreimbursed medical expenses shall be paid fifty percent (50%) by each party. In the event Defendant fails to pay any cash medical Support or other payment, as such failure is certified each month by the Title IV-D Division in which court-ordered support is delinquent in an amount equal to the support due and payable for a one-month period of time, Defendant may be required to appear in Court on a date to be determined by the Court and show cause why such payment was not made. In the event that Defendant fails to pay and appear as ordered, a warrant shall be issued for his arrest.
- 9. All parties shall provide written documentation of their address, telephone number, social security number, and name and address of their employer, whether or not they have access to employer related health insurance coverage, and, if so, the health insurance policy information to the Clerk of the District Court forthwith. All parties shall also advise the Clerk of any changes in such information between the time of the entry of this Order and the payment of this judgment in full.
- Immediate income withholding shall be implemented in accordance with the Nebraska Income Withholding for Child Support Act.
