

AN ORDINANCE vacating 7th Street from North Property Line Jackson Street to South Property Line Farnam Street. Howard Street from West Property Line of 6th Street to East Property Line of 7th Street. Howard Street from West Property Line of 7th Street to East Property Line of 8th Street. Harney Street from West Property Line of 6th Street to East Property Line of 7th Street. Harney Street from West Property Line of 7th Street to East Property Line of 8th Street. East and West alley between Jackson and Howard Street from 6th Street to 7th Street. East and West alley between Jackson Street and Howard Street from 7th Street to 8th Street. East and West alley between Howard Street and Harney Street from 6th Street to 7th Street. East and West alley between Harney Street and Farnam Street from vacated 6th Street to 7th Street. East and West alley between Harney Street and Farnam Street from 7th Street to 8th Street. All in the Northwest $\frac{1}{4}$ Section 23-15-13 and the Southwest $\frac{1}{4}$ Section 23-15-13, in the City of Omaha and providing the effective date hereof.

WHEREAS, petition representing owners of more than 75 percent of the property abutting on 7th Street from North Property Line Jackson Street to South Property Line Farnam Street. Howard Street from West Property Line of 6th Street to East Property Line of 7th Street. Howard Street from West Property Line of 7th Street to East Property Line of 8th Street. Harney Street from West Property Line of 6th Street to East Property Line of 7th Street. Harney Street from West Property Line of 7th Street to East Property Line of 8th Street. East and West alley between Jackson Street and Howard Street from 6th Street to 7th Street. East and West alley between Jackson Street and Howard Street from 7th Street to 8th Street. East and West alley between Howard Street and Harney Street from 6th Street to 7th Street. East and West alley between Howard Street and Harney Street from 7th Street to 8th Street. East and West alley between Harney Street and Farnam Street from vacated 6th Street to 7th Street. East and West alley between Harney Street and Farnam Street from 7th Street to 8th Street. WHEREAS, said property owners have in and by said petition waived any and all damages that may be occasioned by said vacation;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That 7th Street from North Property Line Jackson Street to South

Property Line to Farnam Street. Howard Street from West Property Line of 6th Street to East Property Line of 7th Street. Howard Street from West Property Line of 7th Street to East Property Line of 8th Street. Harney Street from West Property Line of 6th Street to East Property Line of 7th Street. Harney Street from West Property Line of 7th Street to East Property Line of 8th Street. East and West alley between Jackson Street and Howard Street from 6th Street to 7th Street. East and West alley between Jackson Street and Howard Street from 7th Street to 8th Street. East and West alley between Howard Street and Harney Street from 6th Street to 7th Street. East and West alley between Howard Street and Harney Street from 7th Street to 8th Street. East and West alley between Harney Street and Farnam Street from vacated 6th Street to 7th Street. East and West alley between Harney Street and Farnam Street from 7th Street to 8th Street. All in the Northwest 1/4 Section 23-15-13 and

the Southwest 1/4 Section 23-15-13. in the City of Omaha, ne, and is hereby, vacated; The vacating of the property herein described, and the reversion thereof, pursuant to the applicable law, shall be subject to the conditions and limitations that there is reserved to the City of Omaha the right to maintain, operate, repair, and renew sewers now existing therein and in the future construct, maintain, repair and renew additional or other sewers; also the right to authorize the Metropolitan Utilities District of the City of Omaha or any other public utility to construct, maintain, repair or renew and operate now existing or hereafter installed water mains, pole lines, conduits and other similar services or equipment above, on and below the surface of the ground for the purpose of serving the general public or abutting property; and the right so reserved shall also include such lateral connections or branch lines as may be ordered, desired or permitted by the City and to enter upon the premises to accomplish the above purpose at any and all times.

Section 2. That this ordinance shall take effect and be in force after 15 days from and after its passage.
