PARTIAL RELEASE OF INGRESS AND EGRESS EASEMENT AGREEMENT AND DEVELOPMENT AGREEMENT

THIS PARTIAL RELEASE OF INGRESS AND EGRESS EASEMENT AGREEMENT AND DEVELOPMENT AGREEMENT ("Release") is made and entered into effective March 17, 2017 (the "Effective Date"), by and between OMAHA PUBLIC POWER DISTRICT, a public corporation and political subdivision of the State of Nebraska ("Grantor"), and 415 LEAVENWORTH STREET LIMITED LIABILITY COMPANY, a Nebraska limited liability company ("Grantee").

RECITALS:

- Grantor and Grantee are parties to that certain Ingress and Egress A. Easement Agreement dated June 13, 2014, and recorded June 20, 2014, as Instrument No. 2014046900 in the office of the Douglas County Register of Deeds (the "Easement Agreement"), which Easement Agreement concerns, in addition to other real estate, that certain real estate legally described in Exhibit "A" attached hereto and incorporated by reference herein (the "Real Estate").
- B. The Easement Agreement references a certain Development Agreement (the "Development Agreement") by and between Grantor and Grantee for certain development activities that Grantee will perform on Grantor's property.
- C. Grantor and Grantee desire to release the Real Estate from the terms and conditions of the Easement Agreement and the Development Agreement upon the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the foregoing Recitals, which are hereby incorporated by reference and made a contractual part hereof, Grantor and Grantee hereby agree that as of the Effective Date the Real Estate is unconditionally released from the terms and conditions of both the Easement Agreement and the Development Agreement, and thereafter neither the Easement Agreement nor the Development Agreement shall have any further force or effect with respect to the Real Estate.


This Release may be executed in multiple counterparts, each of which shall be deemed an original document, and all of which shall constitute a single instrument.


