



RESTRICTION AGREEMENT

THIS RESTRICTION AGREEMENT, made and entered into this day , 1997, between NP Land Limited Partnership, a Nebraska limited partnership ("NP Land") and Bellevue University, a Nebraska nonprofit corporation ("Bellevue").

RECITALS

NP Land owns the parcel of real estate in Douglas County, Nebraska, described on Exhibit A hereto (the "NP Land Parcel"). Concurrently with execution of this Agreement, NP Land is conveying to Bellevue an adjoining parcel of land described on Exhibit B hereto (the "Bellevue Parcel"). As a condition of the transfer, Bellevue has agreed to the restrictions contained herein.

NOW, THEREFORE, the parties hereto agree as follows:

Restrictions. Bellevue, for itself and its successors and assigns as owner of the Bellevue Parcel, covenants and agrees that (i) no fewer than 5.5 parking stalls per 1,000 square feet of gross building area on the Bellevue Parcel must at all times be maintained on the Bellevue Parcel, (ii) while more than 1,000 square feet of gross building area on the Bellevue Parcel is used in whole or in part for classroom facilities, there must be maintained on the Bellevue Parcel a number of parking stalls not less than the greater of 275 or the number of stalls required by clause (i), (iii) as long as more than 1,000 square feet of gross building area on the Bellevue Parcel is used in whole or in part for classroom facilities the gross building area on all floors on the Bellevue Parcel may not exceed 34,000 square feet, and (iv) space in the Bellevue Parcel may not be leased to then-existing tenants of any of the property described on Exhibit C hereto (the "North Park Development").

Successors and Assigns. This Agreement shall run with the land and bind Bellevue and its successors and assigns as owner of the Bellevue Parcel. The restrictions in Section 1(i), (ii) and (iii) hereof may be enforced by the owners from time to time of the NP Land Parcel. The restriction in Section 1(iv) may be enforced by any owner of any portion of the North Park Development who would be or has been adversely affected by a violation of the restriction in Section 1(iv).
