organized and existing under and by virtue of the laws of the State of New Jersey hereinafter known as the Grantor, for and in consideration of the sum of ONE AND NO/100 (\$1.00) DOLLARS in hand paid does hereby grant and convey unto THE STATE OF NEBRASKA, DEPARTMENT OF ROADS, and to its successors and assigns the following described permanent easement for the purpose of access and the subsequent maintenance of same, situated in Douglas County, and State of Nebraska, to-wit;

A TRACT OF LAND FOR ACCESS PURPOSES LOCATED IN LOT 1, SMELTER PLANT, REPLAT, CITY OF OMAHA, DOUGLAS COUNTY, NEBRASKA, DESCRIBED AS FOLLOWS:



I, Carmel O'Connor, an Assistant Secretary of ASARCO Incorporated, a New Jersey corporation, do hereby certify that the following is a full, true and correct copy of Article V, Section 5.01 of the By-Laws of said Company as amended as of January 30, 2000:

Section 5.01. Contracts. The Board of Directors may take action authorizing any officer or officers, or agent or agents, to enter into any contract or engagement and to execute and deliver any instrument in the name of and on behalf of the Corporation, and such authority may be general or confined to specific instances. Subject to the control and direction of the Board of Directors, the President, any Vice President and the Chief Financial Officer may enter into, execute, deliver and amend bonds, promissory notes, contracts, agreements, deeds, leases, guarantees, loans, commitments, obligations, liabilities and other instruments to be made or executed for or on behalf of the Corporation, provided, however, that the Treasurer and Controller are deemed subordinate officers of the Corporation, without authority to be primary signatories for the Corporation and with authority to attest or countersign a primary signatory of the Corporation, unless otherwise authorized by these By Laws or by the Board of Directors. Subject to any restrictions imposed by the Board of Directors, such officers of the Corporation may delegate such powers to others under his or her jurisdiction, it being understood, however, that any such delegation of power shall not relieve such officer of responsibility with respect to the exercise of such delegated power.

I further certify that by a written consent meeting of the Board of Directors of the Company dated as of November 19, 1999, Mr. Germán Larrea Mota-Velasco was elected Chairman of the Board; Mr. Daniel Tellechea Salido was elected Vice President and Chief Financial Officer, and Messrs. Genaro Larrea Mota-Velasco and Genaro Guerrero Díaz Mercado were each elected Vice President.

I further certify that by a written consent meeting of the Board of Directors of the Company dated as of January 30, 2000, Mr. Xavier García de Quevedo Topete was elected President; Messrs. Manuel E. Ramos Rada, Rodolfo Rubio, Ernesto Durán Trinidad, Brian P. Boylan, Douglas E. McAllister and Robert Ferri were each elected Vice President; Mr. Stephen M. Souza was elected Treasurer; Mr. David B. Foltz was elected Controller; and Ms. Carmel O'Connor was elected Assistant Secretary; and that each person presently holds the respective office to which he or she was elected.
