

CORRECTED DEED OF DISTRIBUTION BY PERSONAL REPRESENTATIVE

ANTHONY STEPANEK, personal representative of the estate of Frank Stepanek, Sr., deceased, Grantor, conveys and releases to Anthony Stepanek, Victor Stepanek, and Jane Vandeventer, Grantees, the following described real estate (as defined in Neb. Rev. Stat. 76-201):

- Tax Lots 2B1 and 3A, Section 13, Township 14 North, Range 1. 12 East of the 6th P.M., Sarpy County, Nebraska, containing 25.49 acres;
- That part of the Northeast Quarter of Section 13, Township 14 North, Range 12 East of the 6th P.M., and part of the Northwest Quarter of Section 18, Township 14 North, Range 13 East of the 6th P.M., more particularly described as follows:

REGISTER OF DEEDS


