## EASEMENT

THIS EASEMENT is made this 15th day of 1994, by City City of La Vista, a Nebraska municipal corporation (hereinafter called "Grantor"), in favor of Victor Stepanek (hereinafter called "Grantee").

WHEREAS, Grantor is the owner of certain real estate located in the Northeast Quarter of Section 13 Township 14 North Range 12 East of the 6th P.M., Sarpy County, Nebraska, more particularly described on the attached Exhibit "A" which property was purchased by Grantor from Grantee (the "Grantor's Property"); and

WHEREAS, Grantee is the owner of certain real estate generally described as that portion of Tax Lot 16 adjoining the east boundary of the Grantor's Property in the Northeast Quarter of Section 13 Township 14 North Range 12 East of the 6th P.M., Sarpy County, Nebraska (hereinafter called "Grantee's Property"); and

WHEREAS, Grantee's property is used as farmland solely for agricultural purposes and Grantor has agreed to grant to Grantee a right of access across Grantor's Property for agricultural equipment.

NOW THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Grantor does hereby grant and convey unto said Grantee, his successors and assigns, at all times for the duration of this Easement, the right of ingress and egress of agricultural equipment for agricultural purposes to and from that portion of Grantee's Property adjoining the east boundary of Grantor's Property over and upon an area approximately 30 feet wide along the southernmost border of the Grantor's Property; provided, however, that Grantor, for itself, its successors and assigns reserves the right from time to time to designate such other location as it may deem appropriate to provide alternative access to Grantee consistent with Grantor's use and development of the Grantor's Property.

This Easement shall commence on the date hereof and shall terminate when Grantee's Property is no longer used by Grantee solely for agricultural purposes.
