## EASEMENT

The undersigned, hereinafter called "Grantor", hereby grants and conveys to OF PUBLIC POWER DISTRICT, hereinafter called "District", its successors and assigns, a perpetual easement to construct, operate and maintain a 3 phase, \_kilo-volt electric transmission line together with necessary poles, wires, guys and other fixtures and appliances, over, upon, along and above the property herein described, upon the terms and conditions set forth.

to the East Line of same to a point of turning, 22 feet North of the South line and 350 feet East of the West line of same, thence Westerly, through Tax Lots 181, 88, and 18 to a point of leaving on the West line of Tax Lot 18 (centerline of Papillion Creek), 23 feet North of the South line of same.

The single wood pole structures to be set upon the above described premises shall not exceed 4 in number, one of which shall be a corner pole located at the above described point of turning and including two certain anchors. In addition one certain anchor will be installed approximately 70 feet North of the above described point of leaving and adjacent to the West line of Tax Lot 18.

CONDITIONS: The Grantor hereby grants to the District, its successors and assigns, the right, privilege and authority to enter upon and pass over said property and the property of the Grantor adjacent thereto for the purpose of constructing, repairing, operating and maintaining said lines and equipment upon the property above described.

The Grantor hereby grants to the District, its successors and assigns, the permanent right, privilege and authority to cut down trees under or within twenty-five (25) feet of the District's lines, and to cut down or trim any trees or limbs of trees on either side thereof as would be a hazard to said lines in breaking off and falling over or against said lines. All refuse or debris from such tree cutting and trimming shall be disposed of by\_ the Distric

The District shall at all times exercise all due care and diligence to avoid any injury or damage to the crops, live stock and other personal property of the Grantor and the District agrees to indemnify and save harmless the Grantor from any and all such damage and loss arising or occuring to such property solely by reason of the District's negligence in the construction, operation and maintenance of said electric line.

This easement is binding on the heirs, executors, administrators and assigns of Grantors.
