

Ordinance No. 1175

An ordinance declaring it necessary to create, and vacating certain parts of commercial b. d., e. g. f. s. p. and s. Streets Railroad Avenue, and the alley extending through Block one and one half (1 1/2) in Crown Park Addition to the city of South Omaha, Nebraska from the southerly end thereof to the south line of Lots Three (3) and Nineteen 1/2 in said block produced, also granting to Union Pacific Railroad Company the right and privilege of laying down maintaining and operating additional railroad tracks across F. Street in the city of South Omaha Nebraska.

Be it ordained by the Mayor and City Council of the City of South Omaha Nebraska:

Section 1.

Necessity exists for the vacation of all of that part of Commercial Street lying between the north line of F. Street and the south line of D. Street in South

Omaha Nebraska, and the same is hereby vacated.

Section II.

Necessity exists for the vacation of all of that part of G. Street which lies West of the West line of Commercial Street and extending to the east line of the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section III.

Necessity exists for the vacation of all that part of D. Street which lies west of the West line of Commercial Street extending to the east line of the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section IV.

Necessity exists for the vacation of all that part of E. Street which lies West of the West line of Commercial Street extending to the east line of the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section V.

Necessity exists for the vacation of all that part of G. Street which lies West of the West line of Commercial Street and extending to the east line of the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section VI.

Necessity exists for the vacation of all that part of H. Street which lies West of the West line of Commercial Street and extending to the east line of the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section VII.

X
Necessity exists for the vacation of all that part of I. Street which lies West of the West line of Commercial Street and extending to the east line of the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section VIII.

Necessity exists for the vacation of all that part of P. Street which lies between the West line of Twenty Sixth Street and Railroad Avenue and the same is hereby vacated.

Section IX.

Necessity exists for the vacation of all that part of S. Street lying between Twenty fifth Street and Railroad Avenue, and the same is hereby vacated.

Section X.

Necessity exists for the vacation of the Alley extending through Block one and one half ($1\frac{1}{2}$) in Brown Park Addition to the City of South Omaha, from the Southerly end of said alley to the south line of Lots Three (3) and Nineteen (19) in said Block produced and the same is hereby vacated.

Section XI.

Necessity exists for the vacation of all of Railroad Avenue extending from the south line of F. Street to the south line of Lot Three (3) in Block Fifty Seven (57) in South Omaha extended Westerly across Railroad Avenue to the right of way of Union Pacific Railroad Company and the same is hereby vacated.

Section XII.

Necessity exists for the vacation of all of Railroad Avenue from the south line of Lot two (2) in Block Eighty two (82) in the City of South Omaha Nebraska, produced Westerly to the east line of the right of way of Union Pacific Railroad Company extending to the West line of Section Ten (10) Township Fourteen (14) North of Range Thirteen (13) East of the Sixth Principal Meridian, Where said Railroad Avenue crosses the Section line, and the same is hereby vacated.

Section XIII.

Necessity exists for the vacation of all of Railroad Avenue from the West line of Section ten (10) above mentioned to the West line of twenty fourth (24) Street where the same is intersected by Railroad Avenue and the same is hereby vacated.

Section XIV.

The right and privilege is hereby granted to Union Pacific Railroad Company to lay down, maintain and operate upon the grade of the railroad tracks of said railroad additional tracks across F. Street between the West line of Commercial street and the West

right of way line of said railroad company.

Section XV.


The Mayor and City Clerk, and other proper officers of the City of South Omaha are hereby authorized directed and required to make execute and deliver to Union Pacific Railroad Company, or Union Stock Yards Company of Omaha (Limited) in the name of the city of South Omaha Nebraska, and under its corporate seal any contract or contracts conveyance or conveyances necessary to fully perform and carry out the terms of this ordinance.

Section XVI.

This ordinance shall take effect and be in force from and after its passage, approval and publication.
