

1 AN ORDINANCE closing to vehicular traffic all of 11th Street from
2 the South right-of-way line of Douglas Street to the North
3 right-of-way line of Farnam Street located in the City of
4 Omaha, Douglas County, Nebraska, and to construct thereon
5 portions of the Central Park Mall and to landscape, beautify
6 and enhance the above described public way, subject to the
7 approval of the City Council.

8 WHEREAS, Section 14-385, Revised Statutes of Nebraska, 1943, as
9 amended, provides that the City may prohibit vehicular
10 travel upon any street or other public way to construct a
11 mall thereon and to landscape and beautify the same, without
12 petition; and,

13 WHEREAS, 11th Street between the South right-of-way line of Douglas
14 Street and the North right-of-way line of Farnam Street is
15 an area in the Central Park Mall, soon to be under con-
16 struction; and,

17 WHEREAS, 11th Street is not a through street and carries only
18 local Central Business District traffic; and,

19 WHEREAS, the closing of 11th Street to vehicular travel would
20 greatly expedite construction of the Central Park Mall, en-
21 hance the appearance of the area and provide aesthetic bene-
22 fits for the added pleasure of people who will use said mall;
23 and,

24 WHEREAS, the Housing and Community Development Department of the
25 City of Omaha has requested the closing of said area and the
26 Omaha City Planning Board approved such closing on August 17,
27 1977, as being in conformance with the Master Plan.

28 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

29 Section 1. That 11th Street from the South right-of-way
30 line of Douglas Street to the North right-of-way line of Farnam
31 Street in the City of Omaha, Douglas County, Nebraska, be and
32 hereby is closed to vehicular travel.

1 Section 2. That there shall be constructed thereon, portions
2 of the Central Park Mall improvements, and said area shall be
3 landscaped, beautified and enhanced in such manner as the City
4 Council may deem proper, all of said Mall improvements being
5 subject to the approval of the City Council.

6 Section 3. That the improvements hereby authorized are of
7 general benefit to all of the citizens of the City of Omaha and
8 will provide for pedestrian travel on the Mall to be constructed
9 in this area.

10 Section 4. That this Ordinance shall take effect and be in
11 force fifteen (15) days from and after the date of its passage.

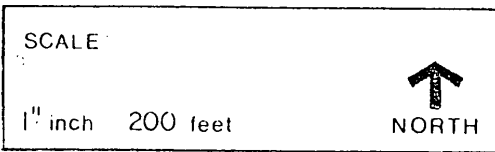
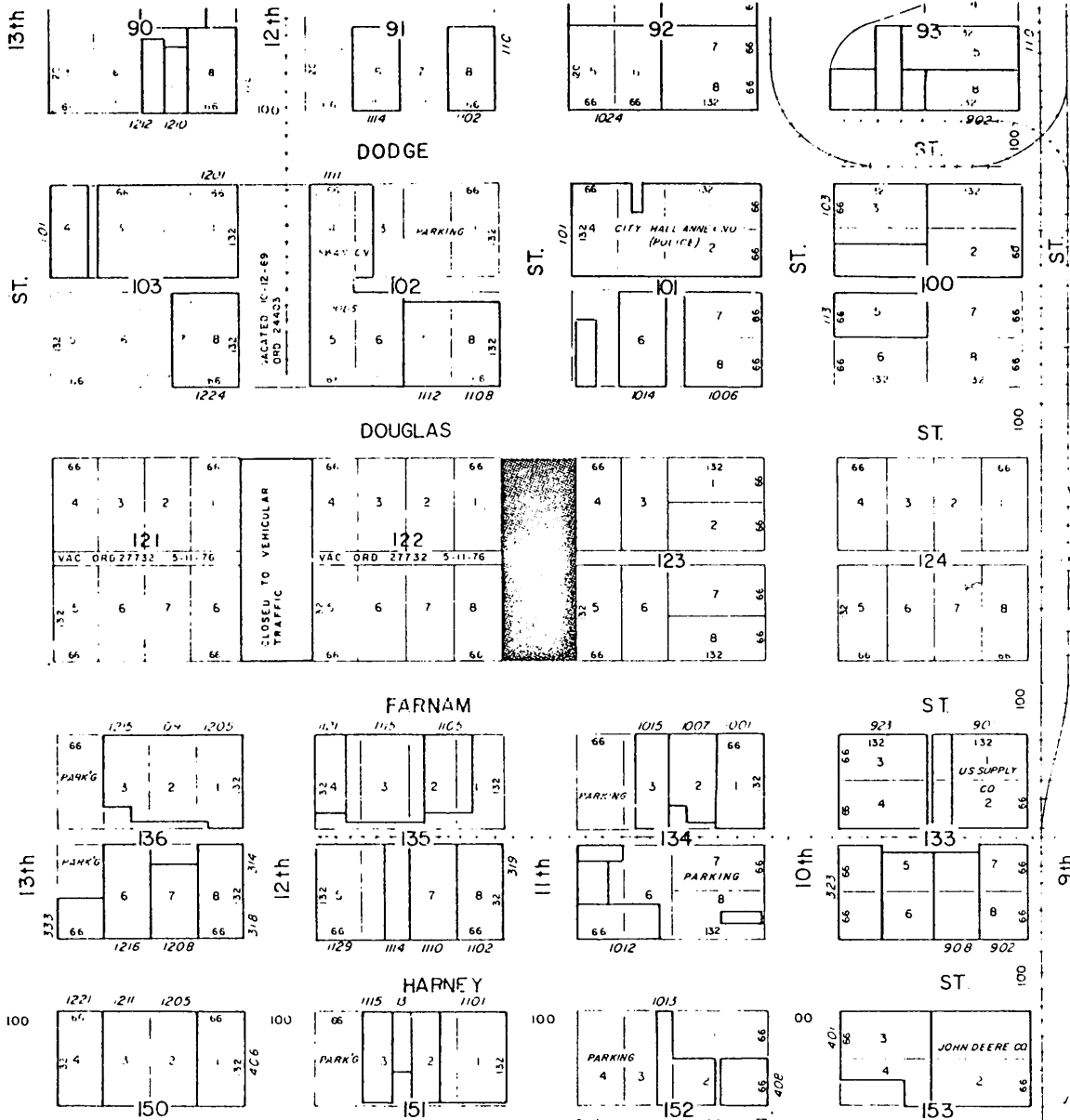
