WARRANTY DEED - to the City of Omaha

KNOW ALL MEN BY THESE PRESENTS, that GERALD M. and GENEVA M. MEDLEY, Husband and Wife, Parties of the First Part, in consideration of Seven Thousand Five Hundred and no/100 (\$7,500.00) Dollars and other good consideration, in hand paid, do hereby grant, bargain, sell, convey, and confirm unto THE CITY OF OMAHA, a Municipal Corporation, organized and existing under and by virtue of the Laws of the State of Nebraska, the following described real estate, situated in the County of Douglas and State of Nebraska, to-wit:

The North 57 1/2 Feet of the East 22 Feet
of Lot 4, in Block 122, Original City of
Omaha, as surveyed, platted and recorded
in Douglas County, Nebraska

together with all tenements, hereditaments, and appurtenances to the same belonging, and all the estate, title, dower, right of homestead, claim or demand whatsoever of the said Parties of the First Part, of, in or to any part thereof;

TO HAVE AND TO HOLD the above described premises, with the appurtenances, unto the said THE CITY OF OMAHA and its successors and assigns forever, and we, the said Parties of the First Part, grantors herein, for ourselves and our successors or assigns, do covenant with the said THE CITY OF OMAHA and with its successors and assigns that we are lawfully seized of said premises, that they are free from encumbrance, except taxes, special assessments and encumbrances of record; that we have good right and lawful authority to sell the same, and that we will and our successors and assigns shall warrant and defend the same unto the said THE CITY OF OMAHA and its successors and assigns, forever, against the lawful claims of all persons whomsoever.

Grantee hereby covenants that this property or any interest therein may not be sold, leased, or otherwise transferred without the prior written approval of the Secretary of Housing and Urban Development of the United States Government, his designee, or any successor thereto.
