ORDINANCE NO. 19047

1 AN ORDINANCE creating and ordering construction of Sidewalk Improvement District No. 75,
2 defining the limits thereof, providing for the construction of public sidewalks therein, providing for the
3 payment of the cost thereof, designating the property to be benefitted and repealing all ordinances or parts
4 of ordinances in conflict herewith.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That Sidewalk Improvement District No. 75, of the City of Lincoln, Nebraska, be and
7 the same is hereby created. Said Sidewalk Improvement District shall include that area bounded on the
8 north by Fletcher Avenue; on the east by 84th Street; on the south by Pine Lake Road; and on the west by
9 Northwest 49th Street; with construction of sidewalks as approved by the Director of Public Works and
10 Utilities for the following described real estate benefitted to-wit:

1 The cost of constructing the sidewalks in said District, including the cost of grading the sidewalk
2 space and public street between the curb line and the property line and all expenses incidental to all such
3 improvements shall be assessed against the property benefitted in said District in proportion to the benefits
4 not exceeding the cost thereof.

5 Section 2. That all ordinances and parts of ordinances in conflict herewith be and the same hereby
6 are repealed.

7 Section 3. This ordinance shall take effect and be in force from and after its passage and publication
8 according to law and be it resolved that Sidewalk Improvement District No. 95 is hereby ordered
9 constructed with passage of this ordinance.


