## AN ORDINANCE OF THE VILLAGE OF BROCK, NEBRASKA VACATING THE FOLLWING STREETS AND ALLEYS:

THAT PORTION OF WALNUT STREET RUNNING FROM 1<sup>ST</sup> STREET TO 3<sup>RD</sup> STREET;  
 THAT PORTION OF MAIN STREET RUNNING FROM 1<sup>ST</sup> STREET TO 2<sup>ND</sup> STREET;  
 THAT PORTION OF MAIN STREET RUNNING FROM 2<sup>ND</sup> STREET TO 3<sup>RD</sup> STREET;  
 THAT PORTION OF LAFAYETTE STREET RUNNING FROM 1<sup>ST</sup> STREET TO THE  
 MISSOURI PACIFIC RAILROAD RIGHT OF WAY; THAT PORTION OF JOHNSON  
 STREET RUNNING FROM 1<sup>ST</sup> STREET TO THE MISSOURI PACIFIC RAILROAD RIGHT  
 OF WAY; THAT PORTION OF 3<sup>RD</sup> STREET RUNNING FROM MAIN STREET TO THE  
 MISSOURI PACIFIC RAILROD RIGHT OF WAY; THAT PORTION OF 2<sup>ND</sup> STREET

 VILLAGE LIMIT; THAT PORTION OF 5<sup>TH</sup> STREET RUNNING FROM JOHNSON STREET  
 WEST TO THE VILLAGE LIMIT; THAT PORTION OF 6<sup>TH</sup> STREET RUNNING FROM  
 JOHNSON STREET WEST TO THE VILLAGE LIMIT; THAT PORTION OF 7<sup>TH</sup> STREET  
 RUNNING FROM JOHNSON STREET WEST TO THE VILLAGE LIMIT; THAT PORTION  
 OF STREET UNKNOWN WITHIN THE VILLAGE LIMITS OF BROCK RUNNING ALONG  
 THE WEST VILLAGE LIMIT OF BROCK, NEBRASKA FROM 1<sup>ST</sup> STREET TO 9<sup>TH</sup>  
 STREET; THAT PORTION OF 1<sup>ST</sup> STREET RUNNING FROM WALNUT STREET EAST  
 TO VILLAGE LIMIT OF BROCK NEBRASKA, ALL WITHIN THE VILLAGE OF BROCK,  
 NEMAHA COUNTY, NEBRASKA WITH THE VILLAGE OF BROCK RESERVING A  
 PUBLIC UTILITIES EASEMENT

Be it ordained by the Chairmen of the Board of Trustees of the Village of Brock, Nebraska

1. The Board of Trustees finds it is in the best interest of the village that the real estate described above is vacated. The Village reserves an easement for maintaining any or all utilities.
2. The Board of Trustees specifically finds there should be no damages sustained by the citizens of the Village of Brock as a result of the vacation and therefore, no damages will be incurred or paid as a result of this ordinance.

- 3. The above-described real estate is now vacated.
- 4. This Ordinance shall take effect and be in force its passage, approval, and publication as required by law.
