

ORDINANCE NO. 1989-4
OF THE VILLAGE OF BROCK, NEBRASKA.

AN ORDINANCE VACATING STREETS AND ALLEYS IN STARR AND
CAMPBELL'S ADDITION TO SAID VILLAGE AS FOLLOWS:

NORTH/SOUTH ALLEY IN BLOCK 1;
NORTH/SOUTH ALLEY IN BLOCK 2;
NORTH/SOUTH ALLEY IN BLOCK 4;
NORTH/SOUTH ALLEY IN BLOCK 6;
NORTH/SOUTH ALLEY IN BLOCK 7;
NORTH/SOUTH ALLEY IN BLOCK 10;
NORTH/SOUTH ALLEY IN BLOCK 11;
FIRST STREET FROM THE WEST EDGE OF LAFAYETTE
STREET TO THE WEST EDGE OF BLOCK 2;

AND PROVIDING WHEN THIS ORDINANCE SHALL BE EFFECTIVE.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF
THE VILLAGE OF BROCK, NEBRASKA:

SECTION 1: VACATION OF STREETS:

North/South Alley in Block 1;
North/South Alley in Block 2;
North/South Alley in Block 4;
North/South Alley in Block 6;
North/South Alley in Block 7;
North/South Alley in Block 10;
North/South Alley in Block 11;
First Street from the West edge of Lafayette
Street to the west edge of Block 2;

above being in Starr and Campbell's Addition to the Village of
Brock, Nebraska, are hereby vacated. The Board of Trustees of
said Village hereby declare that said streets are not now used
and have not for a lengthy period of time been used as public
streets within said Village; that the vacation of said streets
would be expedient and for the public good of said Village; and
that said vacation shall be as provided and in accordance with
the Statutes of the State of Nebraska pertaining thereto.

SECTION 2: WHEN OPERATIVE. This Ordinance shall be in
full force and effect upon its passage, approval and posting
