

ORDINANCE NO. 1989-5
OF THE VILLAGE OF BROCK, NEBRASKA.

AN ORDINANCE VACATING STREETS AND ALLEYS IN CLINTON'S
ADDITION TO SAID VILLAGE AS FOLLOWS:

EAST/WEST ALLEY IN BLOCK 1;
NORTH/SOUTH ALLEY IN BLOCK 2;
NORTH/SOUTH ALLEY IN BLOCK 3;
NORTH/SOUTH ALLEY IN BLOCK 4;
NORTH/SOUTH ALLEY IN BLOCK 6;
MAIN STREET FROM THE SOUTH EDGE OF FIRST STREET TO
THE NORTH EDGE OF THIRD STREET;
LAFAYETTE STREET FROM THE SOUTH EDGE OF FIRST STREET
TO THE NORTH EDGE OF SECOND STREET;
FIRST STREET FROM THE EAST EDGE OF ITS INTERSECTION
WITH WALNUT STREET TO THE WEST EDGE OF ITS
INTERSECTION WITH LAFAYETTE STREET;

AND PROVIDING WHEN THIS ORDINANCE SHALL BE EFFECTIVE.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF
THE VILLAGE OF BROCK, NEBRASKA:

SECTION 1: VACATION OF STREETS:

East/West alley in Block 1;
North/South alley in Block 2;
North/South alley in Block 3;
North/South alley in Block 4;
North/South alley in Block 6;
Main Street from the South edge of First Street to
the North edge of Third Street;
Lafayette Street from the South edge of First Street
to the North edge of Second Street;
First Street from the East edge of its intersection
with Walnut Street to the West edge of its
intersection with Lafayette Street;

above being in Clinton's Addition to the Village of
Brock, Nebraska, are hereby vacated. The Board of Trustees of
said Village hereby declare that said streets are not now used
and have not for a lengthy period of time been used as public
streets within said Village; that the vacation of said streets
would be expedient and for the public good of said Village; and
that said vacation shall be as provided and in accordance with

the Statutes of the State of Nebraska pertaining thereto.

SECTION 2: WHEN OPERATIVE. This Ordinance shall be in full force and effect upon its passage, approval and posting according to law.
