WITNESSETH,

That the said party of the first part in consideration of the covenants contained herein, hereby grants, conveys, remise, release, and quit claim unto the second party, here successors and assigns, an easement for ingress and egress at the following locations, and limited as follows:

> One commercial entrance, not to exceed 40 feet in width, to provide ingress and egress to property of the owner, the centerline of which is located 552.1 feet northerly from the South line of the Southwest Quarter of the Southeast Quarter of Section 14, Township 18 North, Range 11 East of the 6th P.M., Washington County, Nebraska, as measured along the centerline of the highway and being on the westerly side of said highway.

This driveway voids and supersedes the commercial entrance previously granted on Executrix's deed dated March 22, 1965, and filed for record in the Office of the Register of Deeds of Washington County, Nebraska, on April 15, 1965, in Book 89, Pages 387-389 and located 647.1 feet northerly from said South line as measured along the centerline of the highway.

And also, one commercial entrance, not to exceed 40 feet in width, to provide ingress and egress to property of the owner, the centerline of which is located 552.1 feet northerly from the South line of the Southwest Quarter of the Southeast Quarter of Section 14, Township 18 North, Range 11 East of the 6th P.M., Washington County, Nebraska, as measured along the centerline of the highway and being on the easterly side of said highway.

This driveway voids and supersedes the commercial entrance previously granted on Executrix's deed dated March 22, 1965, and filed for record in the Office of the Register of Deeds of Washington County, Nebraska, on April 15, 1965, in Book 89, Pages 387-389 and located 647.1 feet northerly from said South line as measured along the centerline of the highway

The foregoing driveways shall be used only for the purposes set forth herein, and upon abandonment of such uses, this easement shall be void and cause such right of ingress and egress to revert to the grantor.
