WHEREAS, the Board of County Commissioners of Douglas County, Nebraska, on the 2nd day of March, 1971, adopted a resolution fixing Tuesday, the 23rd day of March, 1971 at 10:10 A.M., in the County Board Room of Douglas County, Nebraska, as time, date and place for a public hearing thereon; and

WHEREAS, the Board of County Commissioners of Douglas County, Nebraska, caused such resolution to be published in the Daily Record, a legal newspaper in Douglas County, Nebraska, once a week for three (3) consecutive weeks, and further caused copies of the resolution fixing the time, date and place of said public hearing to be served upon all of the owners of land abutting on or adjacent to the streets to be vacated by mailing the same, by certified mail to the last known address of each owner more than two (2) weeks in advance of the hearing; and

WHEREAS, it was brought to the attention of the Board of County Commissioners that the property described above assumed that the westerly lin e of the Southwest quarter of the Northwest quarter of Section 21 was bearing North 00° 36' 45" West; and

WHEREAS, There was a request that if the Board were to vacate the property it should include an alternative description which assumed that the westerly line of the Southwest quarter of the Northwest quarter of Section 21 was bearing North 00° 05' 40" West; and

WHEREAS, the Douglas County Highway Superintendent studied the alternative description and found it to be identical to the former description and stated that he had no objection to the inclusion of the alternative description in the vacation; and

WHEREAS, said streets do not lie within a township in a County operating roads on a township basis; and
