## LAND SURVEYOR'S CERTIFICATE

I hereby certify that this plat, map, survey or report was made by me or under my direct supervision and that I am a duly Registered Land Surveyor under the laws of the State of Nebraska.

## LEGAL DESCRIPTION:

That part of the former Nebraska Highway No. 38 (West Center Road) right of way in the Northeast Quarter of the Southwest Quarter of Section 25, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Beginning at the 5/8" rebar with 1 1/4" yellow plastic cap stamped LS 379 in the east right of way line of Aksarben Drive, at the southwest corner of Lot 2, AKSARBEN VILLAGE REPLAT 1, a subdivision, as surveyed, plotted and recorded in Douglas County, Nebraska; in the east right of way line of Aksarben Drive;

Thence North 69°07'15" East (bearings referenced to the Final Plat of AKSARBEN VILLAGE REPLAT 1) for 59.54 feet along the north right of way line of said former Nebraska Highway No. 38 to a 5/8" rebar at an angle point therein;

Thence South 22°00'21" East for 32.37 feet continuing along said north right of way line to a 5/8" rebar;

Thence along a curve to the left (having a radius of 306.31 feet and a long chord bearing South 25°48'37" East for 37.20 feet) for an arc length of 37.23 feet continuing along said north right of way line;

Thence South 61°52'10" West for 53.69 feet along the extended north right of way line of Mercy Road;

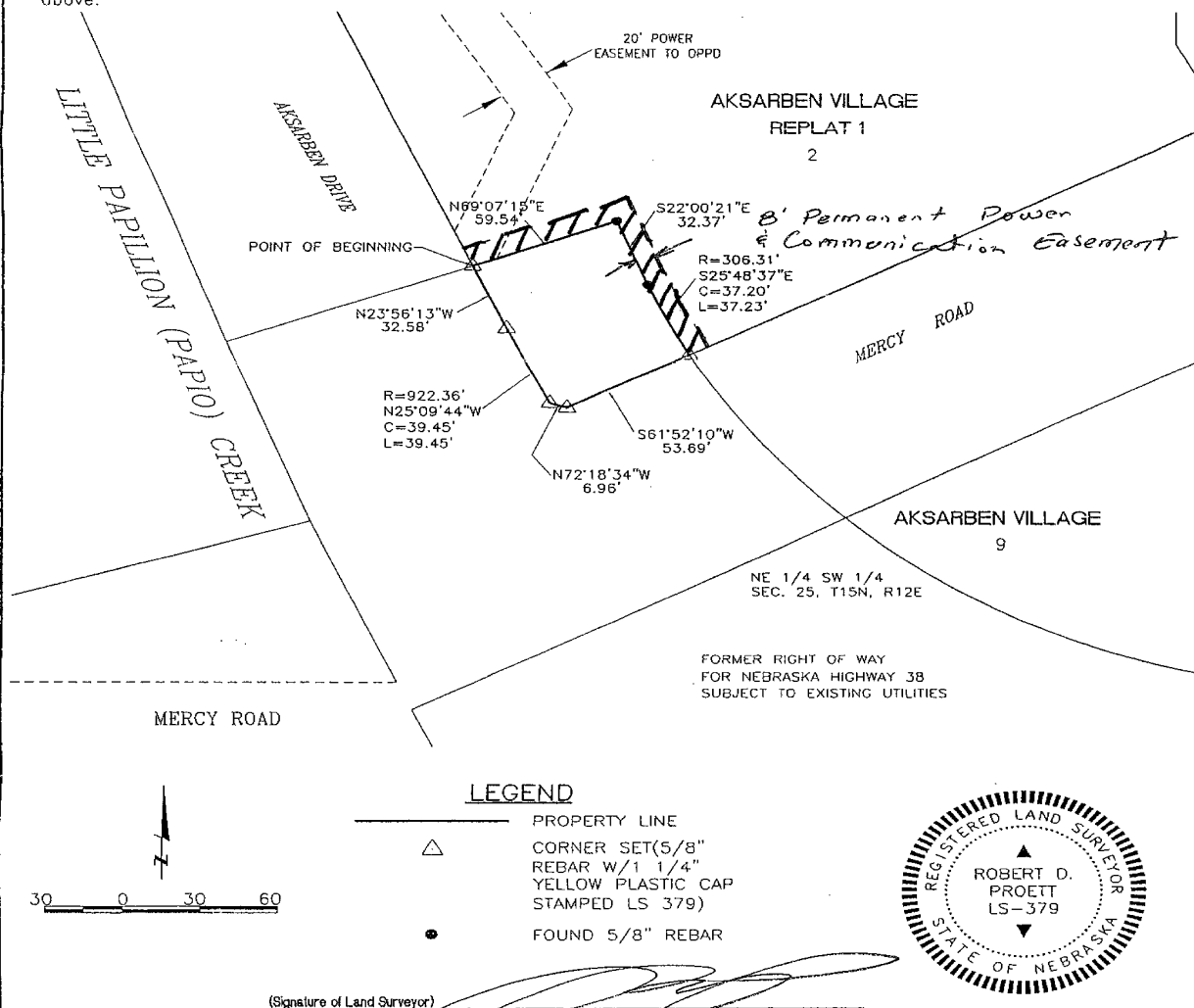
Thence North 72°18'34" West for 6.96 feet;

Thence along a curve to the right (having a radius of 922.36 feet and a long chord bearing North 25°09'44" West for 39.45 feet) for an arc length of 39.45 feet;

Thence North 23°56'13" West for 32.58 feet to the Point of Beginning.

Contains 4,280 square feet.
