
# SURVEYOR'S CERTIFICATE

I HEREBY CERTIFY THAT I HAVE CAUSE TO BE SURVEYED THE SUBDIVISION TO BE KNOWN AS "NORTHMEW 3RD ADDITION", A SUBDIVISION OF LOT 2, BLOCK 1, NORTHMEW 1ST ADDITION, LOCATED IN THE NORTH ONE—HALF OF SECTION 12, TOWNSHIP 10 NORTH, RANGE 6 EAST OF THE 6TH P.M., CITY OF LINCOLN, LANCASTER COUNTY, NEBRASKA AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

REFERRING TO THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 12,
THENCE IN A NORTHERLY DIRECTION, ALONG THE EAST LINE OF THE NORTHEAST QUARTER OF SAID SECTION 12, ON AN ASSUMED BEARING OF
NORTH 00 DEGREES 04 MINUTES 52 SECONDS WEST FOR A DISTANCE OF 811.04 FEET TO THE CENTERLINE OF OLD DAIRY ROAD
THENCE ALONG SAID CENTERLINE OF OLD DAIRY ROAD, NORTH 88 DEGREES 42 MINUTES 53 SECONDS WEST FOR A DISTANCE OF 471.04 FEET
THENCE NORTH 01 DEGREES 17 MINUTES 07 SECONDS EAST FOR A DISTANCE OF 33.00
THENCE ON A CURVE TO THE RIGHT, WITH AN ANGLE OF 42 DEGREES 36 MINUTES 55 SECONDS, A RADIUS OF 117.00 FEET, A CHORD BEARING

OF NORTH 89 DEGREES 24 MINUTES 22 SECONDS WEST, A CHORD LEINGTH OF 11.82 FEET, AND AN ARC DISTANCE OF 11.82 FEET TO A

THENCE NORTH 88 DEGREES 47 MINUTES 20 SECONDS WEST FOR A DISTANCE OF 100.84 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINING 7 LOTS AND A CALCULATED AREA OF 1.696 ACRES MORE OR LESS.

PERMANENT MONUMENTS HAVE BEEN PLACED AT ALL LOT CORNERS, STREET INTERSECTIONS, POINTS OF CURVATURE AND AT ALL OTHER POINTS REQUIRED BY THE CITY OF LINCOLN, LAND SUBDIVISION ORDINANCE, TITLE 26 OF THE LINCOLN MUNICIPAL CODE. ALL DIMENSIONS ARE CHORD MEASUREMENTS UNLESS SHOWN OTHERWISE, AND ARE IN FEET OR DECIMALS OF A FOOT.

THE EASEMENTS SHOWN THEREON ARE HEREBY GRANTED IN PERPETUITY TO THE CITY OF LINCOLN, NEBRASKA, A MUNICIPAL CORPORATION, ALIANT COMMUNICATIONS, TIME WARNER ENTERTAINMENT — ADVANCE/NEWHOUSE, PEOPLES NATURAL GAS, THEIR SUCCESSORS AND ASSIGNS, TO ALLOW ENTRY FOR THE PURPOSE OF CONSTRUCTION, RECONSTRUCTION, REPLACEMENT, REPAIR, OPERATION AND MAINTENANCE OF WIRES, CABLES, CONDUITS, FIXTURES, POLES, TOWERS, PIPES AND EQUIPMENT FOR DISTRIBUTION OF ELECTRICITY, GAS TELEPHONE, CABLE TELEVISION, WASTEWATER COLLECTORS, STORM DRAINS, WATER MAINS AND ALL APPURTENANCES THERETO, OVER, UPON, OR UNDER ANY EASEMENTS SHOWN ON THE FORGOING PLAT. THE CONSTRUCTION OR LOCATION OF ANY BUILDING OR STRUCTURE, EXCLUDING FENCES IN UTILITY EASEMENTS OVER, UPON, OR UNDER ANY EASEMENT SHOWN THEREON SHALL BE PROHIBITED.
