## MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated February 27, 2014, is made and executed between Upstream Brewing Company, L.L.C., a Colorado limited liability company, whose address is 514 S. 11th St., Omaha, NE 68102 ("Trustor") and Mutual of Omaha Bank, whose address is Lakeside Hills, 17041 Lakeside Hills Plaza, Omaha, NE 68130 ("Lender").

DEED OF TRUST. Lender and Trustor have entered into a Deed of Trust dated June 20, 2012 (the "Deed of Trust") which has been recorded in Douglas County, State of Nebraska, as follows:

Recorded June 25, 2012 in Register of Deeds, Douglas County, NE #2012061243.

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Douglas County, State of Nebraska:

Lot Eight (8), Block One Hundred Sixty-Five (165), Original City of Omaha, Douglas County, Nebraska

The Real Property or its address is commonly known as 514 S. 11th St., Omeha, NE. 68102. The Real Property tax identification number is 1530 0003 03.

MODIFICATION. Lender and Trustor hereby modify the Deed of Trust as follows:

The amount of the Loan is increased to \$150,000.00.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

TEMPORARY INCREASE. A Temporary Increase of \$50,000.00 will be made available for advance until May 6, 2014, at which time, the availability will be reduced back to \$100,000.00 and Borrower shall make a required principal reduction if the principal balance exceeds \$100,000.00 as of May 6, 2014.
