



SUBSTITUTION OF TRUSTEE

THIS SUBSTITUTION OF TRUSTEE is made this 3rd day of April, 2018, by Sortino Asset Management Company, LLC., (the "Beneficiary") and Daniel P. Bracht, 128 N. Main Street, P.O. Box 252, West Point, Nebraska 68788 ("Substitute Trustee").

WHEREAS, Mutual of Omaha Bank ("Lender") made a loan to Upstream Brewing Company, LLC a Colorado limited liability company ("Borrower"), evidenced by (i) that certain Promissory Note dated January 24, 2018 (the "Note") in the original stated principal amount of \$100,000.00, executed by Borrower, as borrower, and payable to the order of Lender, which Note is secured by, *inter alia*, (i) that certain Assignment of Rents dated June 20, 2012 ("Assignment of Rents") between Borrower, as grantor, and Lender, as lender, and recorded on June 25, 2012 in the Official Records as Document No. 2012061244, and (ii) that certain Deed of Trust dated June 20, 2012 among Borrower, as trustor, Lender as beneficiary and Lender as trustee, and recorded on June 25, 2012 in the Official Record as Document No. 2012061243, and as amended by that certain Modification of Deed of Trust dated February 27, 2014, between Maker, as trustor, and Lender, as lender, and recorded on February 28, 2014 in the Official Records as Document No. 2014015132 (as amended the "Deed of Trust") and which Note, Assignment of Rents, and Deed of Trust have been endorsed, sold, transferred, assigned, granted, conveyed and delivered by Lender to Sortino Asset Management Company, LLC., a Nebraska limited liability company, by an Assignment of Beneficial Interest under Assignment of Rents and Deed of Trust executed effective as of February 6, 2018, and all with regard to the real estate legally described as:


Lot Eight (8), Block One Hundred Sixty Five (165), Original City of Omaha, Douglas County, Nebraska.


