EASEMENT FOR RIGHT OF WAY

2-WAY JOINT (CITY)

In consideration of the mutual benefits to be derived from the facilities proposed hereinafter, and the further consideration of One Dollar (\$1.00), in hand paid, receipt whereof is hereby acknowledged, the undersigned, owner of Block No. 4 in Ainsworth's First Addition in the City of Friend, Saline County, Nebraska, do hereby grant and convey to THE LINCOLN TELEPHONE AND TELEGRAPH COMPANY and to their successors and assigns, and to the City of Friend, Nebraska, a municipal corporation, its successors, and assigns, the right to construct, reconstruct, perpetually maintain, and operate a joint electric power and telephone line, together with the necessary poles, cables, wires, crossarms, brackets, braces, underground conduits, overhangs, and anchors, etc., with the right to enter said premises for the purpose of repairing, replacing, operating, and maintaining said joint electric power and telephone line, in, over, and above the said property at about the following location:

East and west across said property in line with south side of alley in Blocks #3, 2 and 1 of said Ainsworth's First Addition to Friend.

This grant shall be binding upon the heirs, executors, administrators, successors, and assigns of the grantors herein.
