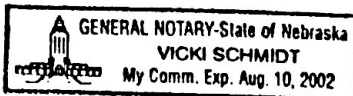
Tracts 9 & 10, set forth on Exhibit 1 attached hereto.

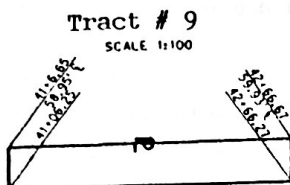

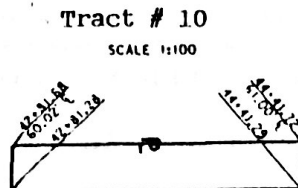
