A tract of land located in part of the Northwest quarter of the Northwest Quarter and in part of the Southwest quarter of the Northwest Quarter of Section 21, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Beginning at the north quarter-quarter corner of the Northwest Quarter of said Section 21; thence southerly on the East line of the West Half of the Northwest Quarter of said Section 21 a distance of 1,563.1 feet; more or less, to the Southeast property corner; thence westerly on the South property line a distance of 8.9 feet; thence northwesterly 64 degrees 12 minutes right a distance of 640.3 feet; thence continuing northwesterly 9 degrees 29 minutes left a distance of 474.3 feet to a point of curvature; thence continuing northeasterly on a 1,015.9 foot radius curve to the left (initial tangent of which coincides with the last described course produced) a distance of 327.3 feet to a point on the West property line; thence northerly on said West property line a distance of 363.8 feet to a point on the North line of said Northwest quarter; thence easterly on said North line a distance of 79.5 feet to the point of beginning, containing 14.73 acres, more or less, which includes 1.24 acres, more or less, previously occupied as a public highway, the remaining 13.49 acres, more or less, being the additional acreage hereby secured;


