acknowledged do hereby grant sell and convey unto said

Brewster of the same county and state the following described real estate situated in said
county and state to wit: A strip of ground on the east side of Government Lot Two (2)
and Section Twenty one in Township Twenty four North Range forty four West of 5th P.M.
Bounded as follows: Commencing at the south east corner of said lot, running
thence west eight feet to a point north parallel with the east line of said lot to a point
seventeen feet south of the north line of said lot, thence east eight feet to the east line of said
lot, thence south to place of beginning. And we hereby grant to said West Brewster and his
heirs and to each of the grantees as shall hereafter purchase from his lot North east Quarter
of the North west fractional Section of said Section Twenty one (21) in government lot one
in said Section. Without or accretions therefrom a perpetual right and easement to have free passage
