## **EASEMENT**

## KNOW ALL MEN BY THESE PRESENTS:

That DENNIS L. BUEL and MALINDA J. BUEL, husband and wife, as joint tenants with right of survivorship and not as tenants in common, herein called "Grantors," record owners of the real property hereinafter described, for and in consideration of the sum of Two Thousand Three Hundred Seven Dollars (\$2,307.00) duly paid, the receipt whereof is hereby acknowledged, and the further consideration of the performance of the covenants and agreements by Grantee as hereinafter set out and expressed, do hereby grant, remise, and relinquish unto the CITY OF HICKMAN, NEBRASKA, a municipal corporation, its successors and assigns, herein called "Grantee," the right, privilege, and easement to construct, reconstruct, maintain, operate, and replace sanitary sewer, and appurtenances thereto belonging, including manholes, over and through the following described real property, to wit:

A permanent sanitary sewer easement composed of a portion of Lot 19, Irregular Tract, located in the Southeast Quarter of Section 28, Township 8 North, Range 7 East of the 6th P.M., Lancaster County, Nebraska, and more particularly described on Attachment "A," which is attached hereto and incorporated herein and made a part of this easement.

TO HAVE AND TO HOLD UNTO THE CITY OF HICKMAN, NEBRASKA, its successors and assigns, so long as such sanitary sewer shall be maintained, together with the right of ingress and egress to said property from the public streets, for the purpose of constructing, reconstructing, inspecting, repairing, maintaining, operating, and replacing said sanitary sewer and appurtenances thereto located thereon, in whole or in part, at the will of Grantee, it being the intention of the parties hereto that Grantors are hereby granting the uses herein specified without divesting Grantors of title and ownership of the rights to use and enjoy the above-described property for any purpose except the construction thereon of permanent buildings, subject only to the right of Grantee to use the same for purposes herein expressed, and subject to any prior leases or easements of record heretofore granted to other parties. Provided that two (2) manholes to the sanitary sewer placed on the property described herein shall be buried a minimum of four (4) feet below the existing surface of the ground.

This instrument, and the covenants and agreements herein contained, shall inure to the benefit of and be binding and obligatory upon the heirs, executors, administrators, successors, and assigns of the respective parties.
