I HEREBY CERTIFY THAT WE HAVE ACCURATELY SURVEYED AND PLACED IRON PINS AT ALL CORNERS OF ALL LOTS, STREETS, AVENUES, ANGLE POINTS AND ENDS OF ALL CURVES IN WILDEWOOD. 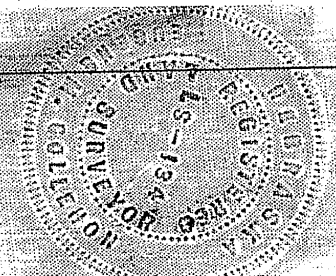

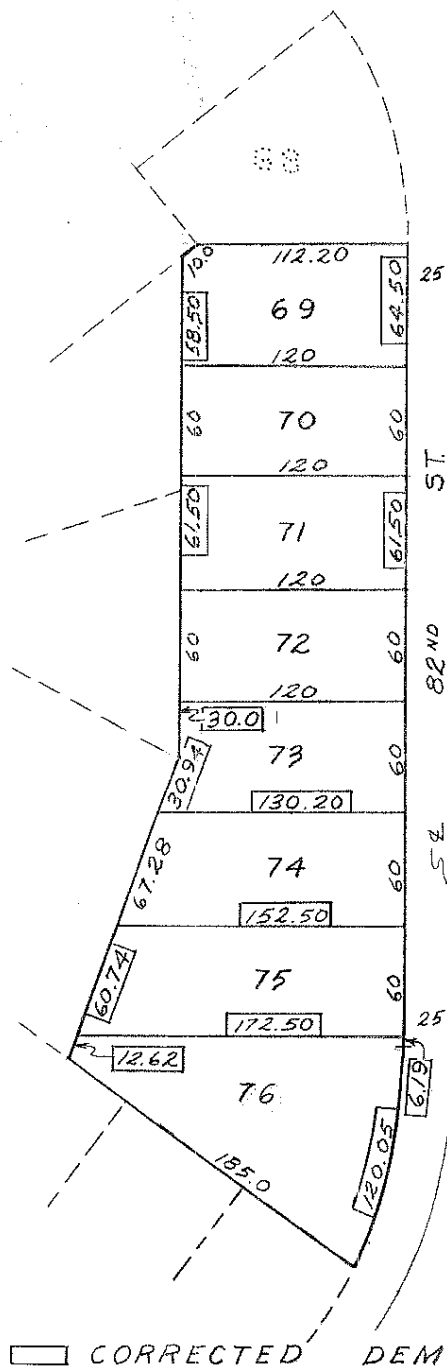
