FOR THE PURPOSE OF CONTROLLING INGRESS AND EGRESS

THIS INDENTURE, Made this 24 day of May, in the year one thousand nine hundred and 62, between

Wildewood Development Company

of the first part and THE STATE OF NEBRASKA of the second part,

WITNESSETH, that the said party of the first part, in consideration of the sum of One and 00/100----- (\$1.00)----- DOLLARS to it duly paid, the receipt whereof is hereby acknowledged has remised, released, and quit-claimed and by these presents does for itself, its heirs, executors and administrators, remise, release and forever quit claim and convey unto the said party of the second part, and to its successors and assigns forever, all rights of ingress and egress to part of the West Half of the Southwest Quarter of Section 11, Township 14 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, over the following described line:

Referring to the Southwest corner of said Section 11; thence easterly on the South line of the West Half of the Southwest Quarter of said Section 11 a distance of 75.0 feet; thence northerly a distance of 33.0 feet to the point of beginning of said controlled access line; said point being 75.0 feet easterly from the West line of said West Half of the Southwest Quarter; thence continuing northerly a distance of 2,006.74 feet to a point 75.0 feet easterly from said West line; thence northeasterly a distance of 217.27 feet to point 160.0 feet easterly from said West line; thence northerly a distance of 77.01 feet to a point on the Northerly property line; said point being 160.0 feet easterly from said West line; said point also being the point of termination of said controlled access line, except ingress and egress will be permitted over one non-restricted drive, the centerline of which is to be located 653.33 feet northerly from the South line of said West Half of the Southwest Quarter as measured along the easterly highway right of way line.

Together with all and singular the hereditaments thereunto belonging.

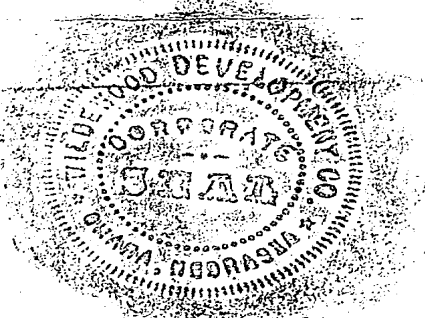

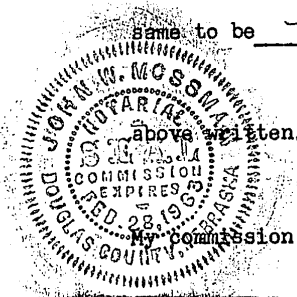
