1. VACATION OF PLAT.
J. Herman Kritenbrink, et al.
to
Whom it May Concern.

KNOW ALL MEN BY THESE PRESENTS:

That whereas, J. Herman Kritenbrink, Clement H. Kritenbrink and Aloysius B. Kritenbrink, are a co-partnership under the name of J. H. Kritenbrink & Sons, and the owners of all of Block One (1); Lots one (1), Two (2), and Three (3), in Block two (2); Lots One (1), and ten (10) in Block Seven (7); Lots One (1), two (2), Three (3), twelve (12) and thirteen (13) in Block eight (8); Lots One (1), two (2), three (3), four (4), five (5), fourteen (14), fifteen (15), sixteen (16), seventeen (17) in Block nine (9); and Lots One (1), two (2), three (3), four (4), five (5), six (6), fifteen (15), sixteen (16), seventeen (17), eighteen (18), Nineteen (19), and twenty (20), Block ten (10), and all of Block Eleven (11), all situated in the first addition to Ralston, a village duly incorporated and organized under the laws of the State of Nebraska: and

WHEREAS the said owners of said lots above described desire to vacate the platting of that part of the first addition to Ralston Place so comprising said lots as aforesaid:

NOW, THEREFORE, we, J. Herman Kritenbrink, Clement H. Kritenbrink, and Aloysius B. Kritenbrink, and each of us individually, and as such co-partnership, do hereby declare that the part of the plat of the first addition to Ralston Place hereinbefore described and consisting of all of Block One (1); Lots One (1), Two (2), and three (3), in Block two (2); Lots One (1), and Ten (10) in Block Seven (7); Lots One (1), Two (2), Three (3), Twelve (12) and thirteen (13), Block eight (8); Lots One (1), Two (2), Three (3), four (4) five (5), fourteen (14), fifteen (15), sixteen (16) and seventeen (17), in Block nine (9); Lots One (1), Two (2), three (3), four (4), five (5), six (6), fifteen (15), sixteen (16) seventeen (17), eighteen (18), nineteen (19), and twenty (20) in Block ten (10); and all of Block Eleven (11); and the adjacent streets and alleys, all situated in the first addition to Ralston, be and the same hereby is vacated, set aside and wholly annulled and the property therein included reduced to acreage.
