CONSENT TO ENCROACHMENT


THIS AGREEMENT is made effective this day of day of , 2005, by and between Sanitary and Improvement District No. 384 of Douglas County, Nebraska ("SID No. 384"), Saint Andrews United Methodist Church, a Nebraska non-profit corporation (the "Church"), and GDR, LLC, a Nebraska limited liability company ("GDR").

RECITALS:

- A. WHEREAS, SID No. 384 is the Grantee of a certain Permanent Sewer and Drainage Easement located on Lot 175, as noted on the original Final Plat of Torrey Pines, that was recorded in the office of the Douglas County Register of Deeds on October 20, 1995, in Deed Book 2016 at Page 601;
- B. WHEREAS, Lot 175, Torrey Pines, was further subdivided into Lots 1 and 2, Torrey Pines Replat 4, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska, by administrative subdivision that was recorded in the office of the Douglas County Register of Deeds on October 15, 1997, in Miscellaneous Book 1225 at Page 516;
- C. WHEREAS, Lot 174, Torrey Pines Addition, together with Lot 1, Torrey Pines Replat 4 Addition, were combined into Lot 1, Torrey Pines Replat No. 6, by administrative subdivision that was recorded in the office of the Douglas County Register of Deeds on May 15, 2003, in Miscellaneous Book 1517, at Page 609;
- D. WHEREAS, Lot 1, Torrey Pines Replat No. 6, was further subdivided into Lots 1 thru 3, inclusive, Torrey Square, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska;
- E. WHEREAS, the Church is the lawful owner of Lot 1, Torrey Square, a subdivision as surveyed, platted and recorded Douglas County, Nebraska; and
- F. WHEREAS, GDR is the owner of Lots 2 and 3, Torrey Square, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska.
- G. WHEREAS, GDR is desirous of developing Lots 2 and 3, Torrey Square, and as part of the proposed development of Lots 2 and 3, Torrey Square, the City of Omaha, Nebraska, is requiring GDR to mitigate the tree canopy loss in substantial accordance with the tree mitigation plan attached hereto as Exhibit A (the "Tree Mitigation Plan");
- H. WHEREAS, SID No. 384 by virtue of its easement rights over Lot 1, Torrey Square, and the Church, by virtue of its ownership of Lot 1, Torrey Square, have agreed to accommodate GDR by allowing the encroachment of the Tree Mitigation Plan as set forth in Exhibit A attached hereto.

NOW, THEREFORE, for and in consideration of this Agreement, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, GDR agrees, at its sole cost and expense, to cause the installation of the Tree Mitigation Plan over Lot 1, Torrey Square, and SID No. 384 and the Church hereby consent to the encroachment of the Tree Mitigation Plan on Lot 1, Torrey Square, as set forth on Exhibit A attached hereto.

This instrument may be executed in two or more counterparts, each of which shall be deemed an original and all of which, when taken together shall constitute one instrument.



This instrument shall operate as a covenant running with both parcels of the above-described land, and shall be binding upon the parties hereto and their respective successors and assigns.


