## EASEMENT

The undersigned, hereinafter called "Grantor", hereby grants and conveys to struct, operate, maintain, replace and remove its underground electric facilities, appurtenances, upon, over, along and under a strip of land one rod wide across the

OMAHA PUBLIC POWER DISTRICT, hereinafter called "District", its successors and assigns, a permanent easement, with rights of ingress and egress thereto, to conconsisting of cables, wires, conduits, manholes, drains, splicing boxes and other property herein described: Hundred Forly CONSIDERATION: PROPERTY DESCRIPTION: The East One-half of the Northeast Quarter (E $\frac{1}{2}$  NE $\frac{1}{2}$ ) of Section Thirty-five (35), Township Five (5) North, Range Thirteen (13) East of the 6th P.M., Nemaha County, Nebraska.

CONDITIONS: The Grantor hereby grants to the District, its successors and assigns, the right, privilege and authority to clear all trees, roots, brush, structures, and other obstructions from the surface and subsurface of said strip and within seven feet (7) thereof and to install gates in any fences crossing said strip. Grantor agrees that grade shall not be reduced more than two feet (2') in elevation without the prior approval of the District. The Grantor understands that a single pole and appurtenances may be used to provide service to this property.

In granting this easement, it is understood that said cables shall be buried below plow depth in order to not interfere with the ordinary cultivation of the strip, and damages to fences and growing crops arising from the construction and maintenance of the aforesaid system shall be paid for by the District.

The Grantor covenants that he/they has/have lawful possession of said real estate, good, right and lawful authority to make such conveyance and that his/her/ their heirs, executors, administrators, successors and assigns shall warrant and defend the same and will indemnify and hold harmless the District forever against laims of all persons whomsoever in any way asserting any right, title or in-

terest prior to or contrary to this conveyance.
