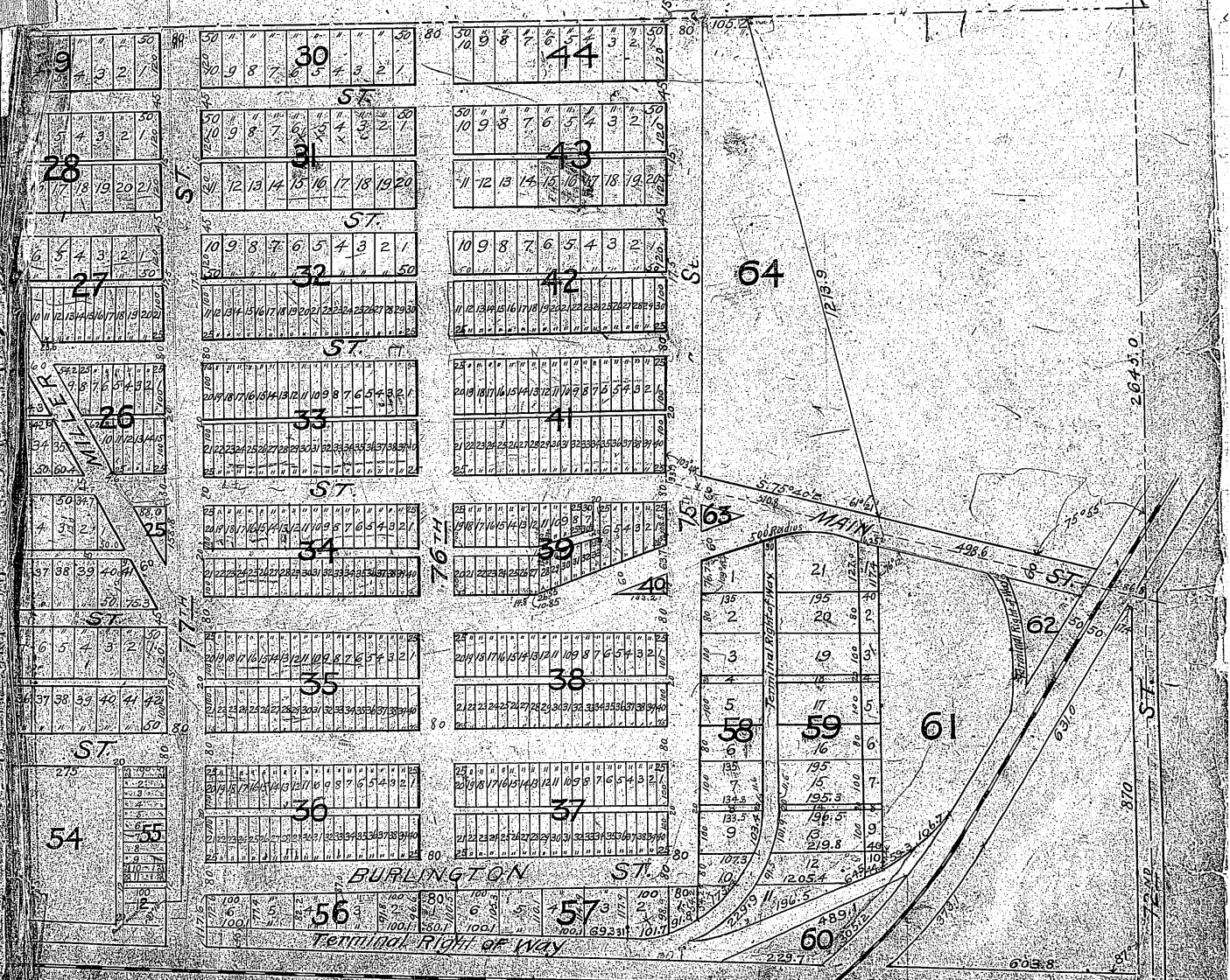

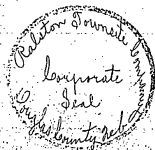
Plat of Dedication.

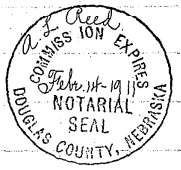

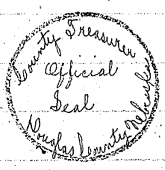
