WHEREAS, a letter has been received from the Sarpy County Surveyor indicating that certain right-of-way located on the Southwest corner of 156th Street and Harrison Street should be deemed excess and recommending that such right-of-way be vacated, and;

WHEREAS, a public hearing has been held in regard to the vacation of such right-of-way and no one appeared in favor of or in opposition to the vacation;

NOW, THEREFORE, BE IT RESOLVED, by the Sarpy County Board of Commissioners, that the right-of-way described as follows be vacated:

That part of the NE 1/4 of Section 15, T14N, R11E of the 6th P.M., Sarpy County, Nebraska, described as follows: Beginning at the NE corner of the said NE 1/4 of Section 15; thence South 87°11'39" West (bearings referenced to the Nebraska State Plane System, South Zone) for 761.00 feet along the north line of the said NE 1/4 of Section 15; thence South 02°08'43" East for 50.00 feet; thence South 02°08'43" East for 11.00 feet; thence North 87°11'39" East for 204.20 feet parallel with and 61.00 feet south of the north line of the said NE 1/4 of Section 15 to the TRUE POINT OF BEGINNING; thence continuing North 87°11'39" East for 91.80 feet parallel with and 61.00 feet south of the said north line of the said NE 1/4 of Section 15; thence South 72°24'26" East for 100.42 feet; thence North 87°11'39" East for 303.00 feet parallel with and 96.00 feet south of the said north line of the NE 1/4 of Section 15; thence South 60°31'55" East for 9.95 feet; thence South 02°08'43" East for 211.50 feet parallel with and 59.00 feet west of the east line of the said NE 1/4 of Section 15; thence North 87°51'17" East for 9.00 feet; thence North 02°08'43" West for 231.10 feet parallel with and 50.00 feet west of the said east line of the NE 1/4 of Section 15; thence North 47°48'19" West for 45.00 feet; thence South 87°11'39" West for 474.73 feet parallel with and 50.00 feet south of the said north line of the NE 1/4 of Section 15; thence South 02°48'21" East for 11.00 feet to the point of beginning.
