

ASSIGNMENT

For One Dollar (\$1.00) and other good and valuable consideration, Siena/Francis House, a Nebraska Non-Profit Corporation, hereby assigns and transfers to NCTHP Limited Partnership, a Nebraska Limited Partnership, in which Siena/Francis House is a general partner, all or any part thereof of Siena/Francis House's rights and obligations in and under that Certain Agreement, as amended, between Siena/Francis House and the City of Omaha approved the 29th day of July, 1997 (the "Agreement") by Resolution No. 2123, and amended on October 27, 1998, by Resolution No. 2994, for the leasing, operation, acquisition and renovation of twenty-two (22) transitional housing units at 4460-4462-4464 and 4266 Redman Avenue, legally described below:

Lot 19, except the West 8 1/2 feet thereof, and Lots 20 and 21, in Laurel Park, an Addition to the City of Omaha, as surveyed, platted and recorded in Douglas County, Nebraska.

This Assignment is made pursuant to the provisions of Section 6.8 of the Agreement approved by the City Council on July 29, 1997, by Resolution No. 2123, and amended October 27, 1998, by Resolution No. 2994, whereby the City of Omaha grants to Siena/Francis House authority to make this Assignment.

By its signature affixed below, NCTHP Limited Partnership, a Nebraska Limited Partnership, accepts the foregoing Assignment and agrees to perform all or any part thereof of the duties and obligations required of the Siena/Francis House, as specified in the Agreement.

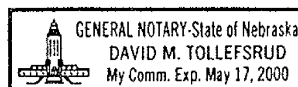

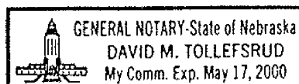

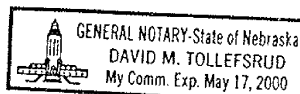
