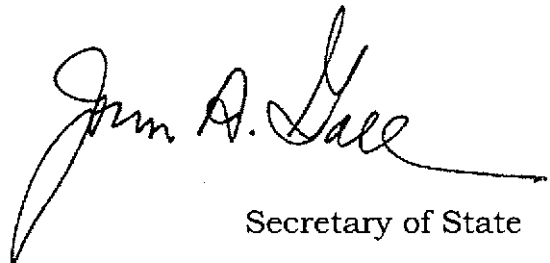

ARTICLES OF CONVERSION
OF
SPACE RENTALS, INC.
INTO
SPACE RENTALS, L.L.C.

Pursuant to the applicable provisions of the Nebraska Business Corporation Act, the undersigned hereby adopts the following Articles of Conversion:

1. The name of the converting entity is SPACE RENTALS, INC., a Nebraska corporation (the "Corporation").
2. The name of the converted entity is SPACE RENTALS, L.L.C., a Nebraska limited liability company (the "LLC").
3. Upon the effective date of the conversion, the Corporation will be converted into the LLC and the Corporation shall thereafter cease to exist.
4. A written Plan of Conversion has been duly adopted by the Corporation's board of directors and approved by the Corporation's shareholders as required by Neb. Rev. Stat. § 21-20,195.
5. The conversion was approved as required by the applicable provisions of the Nebraska Uniform Limited Liability Company Act.
6. The Plan of Conversion is on file at the designated office of the LLC, which is located at 1782 East Calle Colombo, Columbus, Nebraska 68601. A copy of the Plan of Conversion will be furnished to any member of the LLC upon request and without cost.
7. The conversion of the Corporation into the LLC shall be effective on May 5, 2016, which is the date that the LLC's Certificate of Organization takes effect, pursuant to Neb. Rev. Stat. § 21-177(b)(1).
