SUBORDINATION AGREEMENT

KNOW ALL MEN BY THIS PRESENTS:

THIS SUBORDINATION AGREEMENT ("Agreement") is executed effective as of December 31, 2011, by the holders and/or assigns of twenty (20) Lifetime Memberships in Platteview Recreation Association a/k/a Platteview Country Club, Kenneth and Mary Albrecht, Randal and Terri Burr, Thomas and Cindy Dahl, Joseph and Lou Digilio, Jeff and Liz Nannen, Brian Crockett, Derrick and Temple Brannan, Al and Patti Herrera, Mark and Lisa Houlton, Robb and Amy Huck, Kenneth and Cindy Inman, Jim and Kelly Kingsley, John and Sarah Marcuzzo, Jerry and Rita Morehouse, Thomas and Kathy Munch, Bradley and Susan Stockwell, Gene and Betty Theel, Dennis and Tami Timmerman, Timothy and Jill Trusler, and William and Tracey Whitley (collectively referred to herein as "Creditors"), to and in favor of Five Points Bank, a Nebraska bank ("Bank").

- A. Creditors have made loans to Platteview Recreation Association a/k/a Platteview Country Club, a Nebraska nonprofit corporation ("Borrower") by way of certain Lifetime Membership Agreements and secured by a Second Deed of Trust dated November 1, 2002. and filed May 5, 2003, with the Sarpy County Register of Deeds as instrument #2003-23929.
- B. Bank has agreed to extend credit to Borrower on the condition that the Creditors subordinate their rights to debt payments and any liens they have in property owned by Borrower to Bank.
- C. To induce Bank to continue to extend credit to Borrower, Creditors have agreed to subordinate the debt payments owed to them by Borrower and any liens they may have on Borrower's assets, to the due and punctual payment of Borrower's indebtedness to Bank pursuant to the terms and conditions of this Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. <u>Subordinated Indebtedness</u>. Any and all obligations and liabilities of Borrower to Creditors, including, without limitation, principal and interest payments, whether direct or indirect, absolute or contingent, joint or several, secured or unsecured, due or to become due, now existing or later arising and whatever the amount and however evidenced (the "Subordinated Indebtedness"), are hereby subordinated in right of payment to any and all obligations and liabilities of Borrower to Bank from time to time, whether direct or indirect, absolute or contingent, joint or several, secured or unsecured, due or to become due, now existing or later arising and whatever the amount and however evidenced including, without limitation, the liabilities and obligations of Borrower to Bank pursuant to certain Promissory

Notes dated September 27, 2011 and July 21, 2008 and any and all documents, instruments or agreements executed in connection with the loans described by those promissory notes (the "Senior Indebtedness").

- 2. <u>Subordinated Interest in Collateral</u>. Creditors, Stewart Title Guaranty Company as Trustee, and Borrower hereby agree that the Second Deed of Trust dated November 1, 2002 and filed with the Sarpy County, Nebraska Register of Deeds on or about May 5, 2003 for the real property described in Exhibit A attached hereto is subordinate to the Deed of Trust dated July 21, 2008 and filed with the Sarpy County Register of Deeds on or about July 23, 2008 and subsequently assigned to Bank.
- 3. <u>Modification</u>. No waiver or modification of any of its rights under this Agreement shall be effective unless the waiver or modification shall be in writing and signed by an authorized officer on behalf of Bank. Each waiver or modification shall be a waiver or modification only with respect to the specific matter to which the waiver or modification relates.
- 4. <u>Successors and Assigns</u>. This Agreement shall bind and be for the benefit of Creditor and Bank and their respective successors and assigns, and shall be construed according to the laws of the State of Nebraska without regard to conflict of laws principles. If this Agreement is executed by two or more persons, it shall bind each of them individually as well as jointly. Creditors further represent and warrant that they are in fact parties or assignees to the Lifetime Membership Agreements and that they have not assigned or in anyway transferred their rights and/or obligations arising from either the Second Deed of Trust or the Lifetime Membership Agreements to any other person(s).
- 5. <u>Trustee Authorization</u>. The Creditors hereby acknowledge and authorize their Trustee of the Second Deed of Trust dated November 1, 2002 and filed with the Sarpy County, Nebraska Register of Deeds on or about May 5, 2003 for the real property described in Exhibit A attached hereto, Stewart Title Guaranty Company, to enter into and acknowledge this Agreement.
