ORDINANCE NO. 12753

01 An Ordinance creating Water District No. 1094, providing for  
02 the payments of the costs of the improvements therein, designating the  
03 property to be benefited, and repealing all ordinances or parts of  
04 ordinances in conflict herewith.

05 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

06 Section 1. That Water District No. 1094 be and the same is  
07 hereby created; that said water district is created for the purpose of  
08 constructing a water main or water mains to supply water for domestic  
09 and fire purposes, for the following described real estate, which is  
10 hereby included in said water district, to-wit: all of Western State  
11 Industrial Tract; Lots 1, 7, 8, 9, 10, 11, 12, 13, 14, 15 and 16,  
12 Block 1, Western State Industrial Tract 1st Addition; Lots 6 and 7,  
13 including the south half of the east-west alley vacated by Ordinance  
14 No. 10443 abutting Lots 6 and 7, Block 1, Lots 4 through 7, Block 2,  
15 and Lots 13 through 18, Block 5, Burlington Heights; the east 150 feet  
16 of Lots 67 and 93 and the east 150 feet of the north 225.03 feet of  
17 Lot 94, all Irregular Tracts located in the Northeast Quarter of  
18 Section 29, Township 10 North, Range 6 East of the Sixth Principal  
19 Meridian, in the City of Lincoln, Lancaster County, Nebraska.

20 The cost of constructing said water mains, including the cost of  
21 fire plugs, valves, and all other expenses incidental to said improvements,  
22 shall be assessed against the property benefited in said district, not  
23 exceeding the special benefits accruing on account thereof.

24 Section 2. That all ordinances or parts of ordinances in conflict  
25 herewith, be and the same hereby are repealed.

26 Section 3. This ordinance shall take effect and be in force from  
27 and after its passage and publication according to law, but construction  
28 shall not be commenced until ordered by resolution by the City Council.

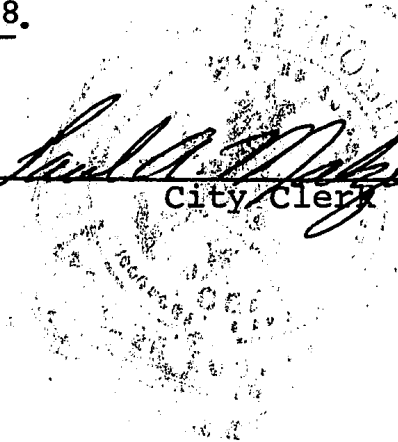
